Bearing work is being done. Old plant was put online during the heavy rains. Mayor delivered DNR response letter on January 24<sup>th</sup>; it was time stamped received by DNR.

**PUBLIC WORKS** Hokanson reported high intensity signs must be in place by 2023. Clerk to check on street light at Saddle Club and S. Orchard Blvd. Ark Construction will start sidewalk repairs when weather is good. Will be working on getting priority list for future street projects. Ault will be working on Newsletter or informational letter to Buffalo Reflex.

#### FINANCIAL STATEMENT

Motion by Counterman to approve January financial statement. Second Mallard. Mallard aye, Bowman aye, Short aye, Miller aye, Counterman aye, Ault aye.

Short brought up HB2242 (Rep. Wiemann) establishes the "Missouri Municipal Government Expenditure Database," to be maintained by State Treasurer Eric Schmitt. The database must include extensive information about a given municipality's expenditures and the vendors to whom payments were made. Municipalities with websites must provide a link to the database. A municipality must provide the information to State Treasurer Eric Schmitt on a quarterly basis or be fined \$100 per day. The fine will be collected by offsetting sales and use tax distributions due to the municipality and will be distributed to the schools of the county.

HB 2242 singles out municipalities and does not include all public entities, such as the state of Missouri, counties and special districts.

HB 2242 is an unfunded mandate that cost cities and taxpayers more than just a "token" amount. It takes more than a "click" of a computer key to provide the excessive amount of information mandated by this bill. Miller will call Representatives to discourage this bill.

#### PARK BOARD

**EMERGENCY MANAGEMENT** Greg Porter announced the 2017 EMP grant has been closed and paid. 2018 EMP grant has been submitted. Porter will be going to trainings including Tactical Storm Spotting and Amateur Ham-Radio training and licensing. March 6<sup>th</sup> will be a state wide tornado drill at 10:00am.

**POLICE DEPARTMENT** Chief Mallory gave 2017 case log numbers. Monthly reports. Discussed speed sign. Speeding complaints on Willow and Chestnut Street. Discussed speed limit on Willow Street may be raised. Police end of year reports have all been submitted. Officer Illig had a baby and will return to work March 11<sup>th</sup>. Officer Gerling will take his vacation a few weeks late due to Illig's maternity leave. All FG officers have been trained on NARCAN; it will be put into service next week. Chief Mallory is redoing police policy manuals.

CITY CLERK Received a SWMOCCFOA Scholarship to attend City Clerk Conference. Time for audit bid. Consensus of Board if Decker & DeGood will continue bid at same cost city will renew. If not city will go out for bids.
