Treasurer's Report - Heather Drabek

- Current Balance as of 06.30.17
 \$30,198.62 minus \$3,000 (CAC funds) = \$27,198.62
- Heather is working with TNB to set up a credit card charge account for CA/N use (to use with an iPad). The startup fee and monthly fee will be waived. This can be used to accept donations at the CAC event, golf outing, etc.

Fundraising Report

- Golf Outing (Mike Viers): We had 17 teams at the outing and netted over \$5,400. We had lots of volunteer help and great weather. We are planning to hold next year's event at Verona Hills on June 27, 2018. Kelli will contact Verona to reserve the date.
- "Give Us a Hand" (Kelli Braun): This fundraiser brought in \$1,709.00 in its first year. Kelli will inventory remaining hands in bundles of 50 for next year. Consider other locations (schools?) to deliver hands next year. Also consider encouraging businesses to put their business cards on the hands as advertising.

Prevention Committee Report - Karissa Schrader

- 5 Mandated Reporter Trainings were held so far this year (69 people trained) all with very positive evaluations
- Supported programs applications are due September 9th.

Publicity Committee Report – Rachel Voss

 - o \$500 donation + gift basket coming from Scheurer
 - o \$3,000 more needed just to open the doors, then funds to operate
