

We started roadside mowing on Monday, 6/17, county Route 18 is done and part of south road was done. On Tuesday, 6/18 we went to Safety Days training. On Wednesday they did more ditching on Hickey Road and finished roadside mowing of South Road, Campbell Lane, 18A, Ballard Road Staso Road. They fixed the road signs for Pratt Road and South Road and cleaned up a tree that fell in the road on Manchester Road.

AGREEMENT TO SPEND TOWN HIGHWAY FUNDS.

TOWN OF HAMPTON
COUNTY OF WASHINGTON

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected for the repair and improvement of highways, and received from the state for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS. The sum of \$ 62,396.49 may be expended for general repairs upon 3200 +/- Feet miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

2. IMPROVEMENTS. The following sums shall be set aside to be expended for the improvement of town highways:

(a) On the road commencing at Carvers Falls Road at the Town Line with Whitehall and leading to 3200 +/- Feet, a distance of 3200 +/- miles, there shall be expended not over the sum of \$ 62,396.49

Thickness 1 3/4 Subbase Resurface




