- April 21 I met with Nashua Fire Rescue Chief Buxton to discuss airport safety/procedures and gate access.
- May 4th I met with Greg Lison, Infinity Aviation to discuss a land lease and development project.
- May 6th I met with Dr. Joshi to discuss T-Hangar development off of the "India Ramp".
- "Foxtrot Ramp & Golf Ramp" project bidding is complete, and the contract has been awarded to Continental Paving.
- Greg Lison and I have located a company to paint the fuel farm. This should be starting next week.
- There is a contractor coming to town on August 1, 2022 to start the painting of 93 Perimeter Road.

AIRPORT ENGINEER'S REPORT

Nik Ippolito appeared on behalf of the airport's engineering consultant, Gale Associates, Inc.

CONSTRUCT ONLY - Pavement Maintenance Phase II (NHDOT No SBG-12-22-2020)

This Project is to reconstruct taxilanes between hangars located on the north-west side of the Airfield (Runway 14 end.)

Project Status:

- Grant Closeout Documents have been accepted by the NHDOT/BA
- Moving forward, this project may be removed from the agenda.

REHABILITATE TAXIWAY 'A' AND ASSOCIATED TAXIWAYS

This Project is for the design and construction phases necessary to rehabilitate Taxiway 'A', install new taxiway edge lighting (MITLs), and to address the grading issues at the intersection of Taxiway 'A' and Taxiway 'D'.

Project Status:

- A grant application for a design-only project has been submitted and accepted by the NHDOT/BA.
- Gale has reached out to the NHDOT/BA for an estimated date for the issuance of this grant. At the time this update was prepared, we are still waiting for a response from NHDOT/BA.

Recommended Actions:

None at this time.

REHABILITATE GOLF RAMP AND FOXTROT RAMP

This project is for the design, and construction necessary to rehabilitate Golf and Foxtrot Ramps at the Airport.

Project Status:

- Bids for this project were opened on April 26, 2022. The low bidder on the project was Continental Paving, Inc. with a bid price of \$1,991,710.00.
- Gale has prepared grant applications for this project which were submitted and accepted by the NHDOT/BA.
- Upon issuance of the grant to fund this project, a Notice of Award and Contract will be sent to the Authority and Contractor for execution.
- Depending on the timing of the grant issuance, construction may begin in the summer of 2022. If the
 grant issuance is delayed, there is a possibility that construction would be postponed until the spring
 of 2023.

Recommended Actions:

GENERAL ITEMS

Funding applications for the competitive grant program under the Bipartisan Infrastructure Law's competitive grant program have been submitted to the FAA. If awarded to the Nashua Airport Authority, the project would be to construct a new Air Traffic Control Tower.

NEW BUSINESS

Infinity Aviation - Hangar Development

Mr. Greg Lison, owner Infinity Aviation, read a letter dated May 18, 2022 addressed to Chairman Woods and Airport Manager Chris Lynch requesting a land lease adjacent to and south of the tower building. Discussion was based on construction of an approximately 80,000 square foot FBO and hangar, ramp construction, parking, and relocation of Taxiway 'A'. Discussion was also had regarding the use of the current building at 79 Perimeter Road. This building will need to be used as an aviation educational purpose as well.

Boire Field Condominium I - Approve and record lease extension for 107 Perimeter Road.

Condominium I for 20 years beginning on August 1, 2022 and terminating on July 31, 2042, upon the same terms and conditions as the Lease now in effect.
