# **City Wide Utility Improvement Project**

Mayor Hardy created a three member Street Improvement Committee which will create a milestone debt service chart and write new ballot language for the second city wide election. Mayor Hardy will serve as an Ad Hoc member. Council Members Wilkie, Gottbreht and Mitchell will be members of the committee.

Council Member Mitchell moved, Council Member Gottbreht seconded, to approve a second election for the City Wide Improvement project. Council Member Mitchell, Council Member Gottbreht seconded, to set the special election to Tuesday, October 6<sup>th</sup>. All members on roll call voted "yes". None voted "no". Motion carried.

Jim Olson, AE2S asked how involved should AE2S be in the new election for the street improvement project. Mayor Hardy stated that AE2S is expected to fully assist with the upcoming election.
