

Dunn Loring Swim Club 2020 Dues Notice

January 31, 2020

The 2020 annual dues payment is \$575, with a reduction for some senior members (see #3). Instead of paying dues, you may choose “Inactive” status and pay the Inactive fee (\$100) or withdraw your membership. **Your payment and documentation must be postmarked by March 15, 2020.** Mail to Dunn Loring Swim Club, PO Box 87, Dunn Loring, VA 22027

To pay your 2020 annual dues

1. Review, update with any additions or corrections directly on the card, sign, and return the enclosed Gate Control Card.
2. Enclose updated photos of any household member under 16 years old. Printed photos can be attached to the back of the Gate Control Card or e-mail a digital file (JPG preferred) to Membership@dlsc.net with your name and membership number included (see Gate Control Card for membership number).
3. Enclose or issue electronically payment of \$575*. Make checks payable to Dunn Loring Swim Club.
*For senior members who have been members at least 5 years, 2020 annual dues are reduced to the following amounts (include copy of proof of age with payment):

Age 65 and over	\$525
Age 75 and over	\$475
4. Enclose Proof of Residency for household members listed as “other permanent members” on the Gate Control Card who are older than 25 years old. Requirements specified at www.dlsc.net [Rules & Bylaws] tab.
5. Fill out and return Response Form (below).

To place your membership on “Inactive” status for the 2020 season

1. Review, update with any additions or corrections directly on the card, sign, and return the enclosed Gate Control Card
2. Enclose or issue electronically payment of \$100. Make checks payable to Dunn Loring Swim Club.
3. Mark the “Inactive Fee” box on the Response Form (below) and return it.

The slots of members choosing inactive status are offered as a Summer Rental to waitlist candidates. Their membership is retained but **they may not access the facilities for the current season or change their status back to Active until the next season.** Members may not designate which waitlist candidate receives the offer.

To withdraw your membership

Send your withdrawal request to Membership@dlsc.net or postal mail it to the address noted above. You will receive an email confirmation and a refund of your equity share minus any outstanding fees.

Late fees apply as follows:

- Annual Dues payment postmarked after March 18 are assessed a \$40 late fee.
- Inactive payments postmarked after April 4 are assessed a \$40 late fee.
- Payments postmarked after April 18 are assessed an additional \$40 late fee.
- Dues unpaid by May 4 result in automatic “Involuntary Inactive” status for the summer season and a \$150 fee, in addition to the late fees.
