**Minutes from March 15, 2022:**

**Borderline Ridge Riders:**

- ❖ Kristal Cote, Borderline Ridge Riders Rep, joined the meeting to get her clubs annual roads permission slip signed by the Board. The Board decided to not sign the permission slip at this time due to some concerns of a certain road that needs to be fixed, and that they would like to have a meeting with the Club's president to discuss this matter. They asked Kristal if she

would speak with Scott Jenness and have him come to our next meeting on April 12, 2022. She agreed to do so.

**Other Business:**

❖ Samuel Thurston, Zoning Board Secretary, joined our meeting to notify the board that the Town Plan is ready to submit. With their only being 2 members at this time the NVDA will not allow the Zoning Board to submit it. He asked the Board if they could help find a person to be appointed to the zoning Board to make it possible to submit the plan. The Board agreed to do what they can to find a person, as Sam and the Town Clerk have already put out several notifications to find someone. Sam is also going to talk to NVDA again to get complete verification of the Town Plan submission, he will be getting back to the Board with his findings as soon as possible.

❖ The Board members signed Municipal weight permits for the following: **Structural Wood Corp, Harrison Redi-mix Corp, AmeriGas, Camp Precast Concrete Products, Inc., Dale E. Percy, Inc., S.D. Ireland, Dan Pepin Excavating & Trucking, Wind River Environmental LLC, Beacon Sales Acquisition, Calkins, and Darren M. Pion**

❖ Alden, Board Chair, signed the contract for Beloin's Computing to be the Town's IT person as he has in years past.

❖ Becky spoke to the Board about Mary possibly leaving us in the near future and wanted to know if we should start advertising now for the position or if we should wait until she gives her notice. The Board were in agreement to wait until she gives an official notice before advertising the position.

❖ The Board asked Becky how the Budgets were coming. She stated that she only had admin to finish and to put the budgets into an explainable spreadsheet.

❖ Darren suggested in the future that when the Town is going to be holding a tax sale that we should post it to the town website , but only the date and time, not the whole list of properties. The other Board members agreed.

❖ Darren brought to the other Board members attention that we were supposed to put the Town field out to bid for haying in September 2021 but was forgotten about. The Board decided after a short discussion that they would put it out to bid by the end of April 2022. Becky and Christy will get the notice put together and present it at the next meeting for approval.
