




On that note, I bid you fair adieu... see you in and about the Temple!

Supreme Council (SJ) Biennial News:

Illustrious James Dean Cole, 33°, was elected Sovereign Grand Commander of the Supreme Council of the Ancient and Accepted Scottish Rite, Southern Jurisdiction Saturday at the Biennial Session being held at the Capital Hilton Hotel in Washington, DC. He replaces Ill: Ronald A Seale 33°, who served in this position for 16 years, since taking the position in October of 2003.

G:. C:. Cole served as the 156th Grand Master of Masons in Virginia in 2001. Prior to Saturday's being installed as Grand Commander, he served as both the Lieutenant Grand Commander of the Supreme Council and as Sovereign Grand Inspector General of Virginia. On January 1, 2003, he was appointed Deputy of the Supreme Council in Virginia and, on October 7, 2003, was crowned as an active member of the Supreme Council. He served as the CEO for the Masonic Home of Virginia in Richmond for many years.



















Thomas D. Murphy, Jr., 33° 03/24/1920-08/01/2019



Thomas Davidson Murphy, Jr. passed away peacefully in his home and surrounded by love on August 1, 2019 in Austin, Texas. He lived 99 amazing years.

Tom was born on March 24, 1920 in Cordell, Oklahoma to Reverend Thomas D. and Anna Christine Murphy.

Tom graduated from Kilgore High School in 1937. He earned a BA in economics and history in 1941 from Austin College, Sherman Texas. Odessa, Texas was his true home, and he lived there from 1938 to 2005 before retiring to Granbury and then Austin. He proudly served his country in WW II. Tom was commissioned an Ensign U.S.C.G.R. at the Coast Guard Academy in New London, Connecticut. He served to the rank of Lt. (j.g.) and was an officer aboard the U.S. Destroyer Escort "Pride" in the Afro-European Theater from 1943-1945. At age 97, he took the Honor Flight to Washington DC and was able to finally see the WW II memorial.

Tom's full and successful business career began in 1950, when he co-founded Murphy and Rochester Real Estate and Insurance Company in Odessa. He was always a community leader, dedicated to nurturing others' lives especially through the Masons, the Kiwanis Club and as a Presbyterian church elder. He became a Master Mason on June 28, 1956 in H.A. McFarland Lodge located in Odessa, Texas. Just a few months later he joined the El Paso Scottish Rite during their Fall Reunion. He was elected a Knight Commander of the Court of Honour on November 12, 1965 and on November 17, 1973 the El Paso Scottish Rite Bodies honored him by electing him to the Rank and Dignity of 33°, Inspector General Honorary. He sponsored many candidates into the Scottish Rite through the years.

Tom had a passion for golf, playing all his adult life until age 92, at courses all over the United States and in Europe. His very favorite course was Pebble Beach. He believed that if you just found the golf course, you would be in the most beautiful place wherever you were. He was proud of shooting his age over 200 times, beginning when he was 78 years old. Tom was patriarch of a large and blended family, which was his greatest treasure and comfort. His family life was filled with great joy as well as tragedy. He was married to Dorothy Lee Kimes from 1941 until she tragically died in 1962. He was married to Rubye Prokish Bowers in 1964 until she passed in 2010. He and Rubye spent many happy times in their Air Stream trailer, traveling to golf tournaments and sightseeing.


