## Safety Procedures for Fox Brush Farm Shows at Waterloo

Fox Brush Farm (FBF) and Waterloo Hunt Club value the safety and well-being of exhibitors, trainers, staff and their family members. In response to the ongoing public health crisis (COVID-19 pandemic), we are implementing procedures for the July 24 & 25 and July 30-August 1, 2021 horse shows, being held at Waterloo Hunt Club. These procedures, using CDC guidelines, seek to safeguard the health of exhibitors, trainers and show staff. In order to successfully limit the transmission of illness during the course of each show, we will require the cooperation of all involved. As this unprecedented time continues, we thank you in advance for your compliance, flexibility and patience. We look forward to making these safe and fun weekends for all involved.

**COVID-19 Screening Questions** If you are feeling unwell, feel unsafe, answer YES to any of the following questions, or are unwilling to comply with the subsequent guidelines, you may not enter the Waterloo grounds.

- 1. Are you are currently suffering from COVID-19 symptoms? (Please see CDC website for current symptoms.)
- 2. In the last 14 days, have you had close contact with someone diagnosed with or displaying COVID-19 symptoms?

## **Covid Protocol**

- Face coverings MUST be worn when 6 feet of separation between individuals is not maintained.
- Face masks must be worn when interacting with show staff and Waterloo staff. Such as, but not limited to Managers, Secretary, Starters.
- Face masks do not need to be worn while mounted, but may be worn without penalty.
- Please have a face mask with you at all times for the above listed situations.
- Social distancing must be practiced at ALL TIMES in accordance with state and/or local regulations.
- Only exhibitors and trainers are allowed in the stabling areas
- In the event of inclement weather, please plan to shelter in your vehicle, rather than the tack room areas.
- NO tents allowed on the property. Chairs may be placed under the trees on hill and under pavilions, as long as they are six feet apart from non-family.
- Waterloo and FBF staff will be sanitizing busy areas including bathrooms on a regular schedule.
- Sanitation items will be available throughout the grounds. Hand washing is encouraged.

## FBF and Waterloo General Safety Guidelines

- All dogs must be leashed at all times.
- Please park in designated areas. Those are: gravel area at top of hill across from stabling or in the grass area by main road. NO parking is allowed near barns, show rings or office area and any other area designated 'No Parking' by Waterloo.
- All riders/exhibitors, trainers, parents/spouses and grooms MUST obey all signs.

## **Show Office Procedures**

- Only FBF staff members will be allowed inside the Secretary Stand.
- Only trainers will be allowed at the window of the Secretary Stand
- All entries must be completed on the FBF Entry Form (available for printing at www.horsehowing.com).
- All entries must be accompanied with a signed open check made payable to Fox Brush Farm. See prizelist for dates. NO open trainer checks will be accepted for individual entry payment.
- All entry forms must be submitted to FBF no later than 9:00 pm on the Tuesday before the start of the show, or a \$20 late fee will be added to the entry.
- Please submit any membership forms and payment (separate check made to Cathy Johnson) with your entry.
- Paper schedules will be in limited supply please visit www.horseshowing.com for daily schedule.
- As always, any questions by a parent or exhibitor must be presented to their trainer who will then relay the information to the show staff.

FBF would like to thank you again for understanding this is a fluid situation and changes may be needed before the Show date and/or as we move through the weekend. We are looking forward to seeing everyone! This COVID-19 pandemic has brought about many differing views regarding the seriousness and implications of the virus.
