2. Meeting led in prayer by Commissioner Riddle.
3. The Pledge of Allegiance was led by Commissioners.
4. Motion made by Commissioner Riddle to approve the Agenda with addition of Memorandum of Understanding between the Long County Board of Commissioners and Action Pact, Inc. and striking number 6 – Budget Amendment for the Senior Center from the agenda. Commissioner Phillips seconded the motion. The motion passed unanimously.
5. Motion made by Commissioner Phillips, seconded by Commissioner Riddle to approve the June 2019 minutes. The motion passed unanimously.
6. Motion made by Commissioner Deloach, seconded by Commissioner Phillips to pay bills. The motion passed unanimously.
7. Motion made by Commissioner Phillips, seconded by Commissioner Deloach to approve the Long County Board of Commissioners Budget for FY 2020. Commissioner Riddle stated he is opposition of any raises being approved with the 2020 budget. Commissioner Richardson opposed. The motion passed 4-1.
8. Motion made by Commissioner Phillips, seconded by Commissioner Riddle to approve and accept the Old Long County High School from the Long County Board of Education. The motion passed without opposition.
9. Motion made by Commissioner Riddle, seconded by Commissioner Phillips to approve the switch energy suppliers from Atlantic Gas to Infinite Energy. The cost would be from \$1.49 a Therm to €76.6 a Therm. The motion passed unanimously.
10. Motion made by Commissioner Phillips, seconded by Commissioner Riddle to approve Deed for donation of South Ludowici Recreation Area to the City. The motion passed unanimously.

11. Motion made by Commissioner Riddle, seconded by Commissioner Deloach to award Carl Bacon the bid for painting Head Start Interior Walls in the amount of \$2200.00. Commissioner Parker opposed and Commissioner Phillips opposed. The motion passed 3-2.
12. Motion made by Commissioner Riddle, seconded by Commissioner Phillips to accept the Memorandum of Understanding between the Long County Board of Commissioners and Action Pact, Inc. for the Long County Senior Center. The motion passed unanimously.
