APRIL 2020 - ITINERARY**

April 18 Sat - Depart for Scotland

April 19 Sun – St. Andrews

Following arrival in Edinburgh, we will journey north to St. Andrews by motor coach. For the duration of our visit, with exception of the last night, we will stay at the delightful four-star Hotel du Vin, within walking distance of the town center and the Old Course. We shall enjoy a Welcome Dinner at the hotel this evening.

April 20 Mon – St. Andrews

Today, we will play the New Course, not really new since it was opened in 1896 and lies alongside the Old Course.

April 21 Tue – St. Andrews

Today, we will play the fabled Old Course, the most hallowed golf course in the world! The Old Course hosts the British Open every five years.

April 22 Wed – St. Andrews

Today is golf-free, allowing us the opportunity to spend the day in Edinburgh, Scotland's beautiful capital city. For those who would prefer to play golf today we can arrange play on one of St. Andrews' other courses.

April 23 Thu – St. Andrews

Today, we will drive a little north to play Carnoustie, another of Scotland's British Open courses. We shall enjoy a Farewell Dinner at the hotel on this final night in St. Andrews.

April 24 Fri – Edinburgh

Today will see us playing the magnificent Kingsbarns, arguably the finest golf course opened in Scotland in the last generation. Later in the day, we will drive to Edinburgh and stay at the Double Tree by Hilton Hotel at the Edinburgh Airport.

April 25 Sat – Return Home

We will depart Edinburgh this morning, arriving home this same day.

DEPOSIT

Initial deposit, due with registration: \$1,000.00 per person
Full balance due on December 18, 2019

CANCELLATION

All deposits and final payment are nonrefundable. In addition, refunds cannot be issued for unused portions of the trip package. Pioneer Golf will not issue refunds for missed tee times, accommodations, etc. due to disrupted air travel. Should a participant cancel and have his or her place taken by a replacement, there will be a name change fee of \$100.00. Notification of cancellation must be received by Pioneer Golf, Inc. in writing. We strongly recommend travel insurance. Please see below.

AIR TRAVEL

Air travel will be arranged by Pioneer Golf on a round trip basis from Austin to Edinburgh. It's estimated that the fare will be in the vicinity of \$1,300.00, but this will not be confirmed until approximately late October of 2019. Details, along with terms and conditions, will be announced then. Purchase of our air ticket is not obligatory.

MEALS

Breakfast included each morning except on arrival day (when it will be served on board the aircraft). Two dinners, welcome and farewell, are included.

HANDICAP

Proof of handicap may be requested by a golf course. Should your handicap be higher than 24 please give us a call before registering.

SIGHTSEEING

A licensed Scottish Tourist Board guide will join the group for sightseeing in Edinburgh.

CADDIES

Prices for caddies range from about \$75.00 to \$100.00 (including gratuity) but are not included in the trip price. Caddies are available at most courses. They are not mandatory. Several months in advance of your departure, we will send you a Caddie and Cart Request form, which details caddie and cart availability at each course on your itinerary.

ELECTRIC CARTS

Electric carts ("buggies") are not as common in Ireland as in North America. Some courses have a fleet of carts, while others may have only one or two. Occasionally, carts are only available with a doctor's note or, in some more restrictive circumstances, with verification of a permanent disability.

PULL CARTS

Most courses have pull carts ("trolleys") available for \$4.00 to \$9.00 per round. Although pull carts cannot be reserved in advance, they are plentiful.

TRAVEL INSURANCE

All deposits and final balance payments are non-refundable. Acts of nature (such as the volcanic ash that canceled about 100,000 flights in 2010 and disrupted air travel again in May 2011 stranding travelers around the world) would not be grounds for a refund. We strongly recommend that you purchase travel insurance since it is the only way that you would be able to recoup your trip cost for canceled or disrupted trips.
