The department logged 143 calls for service in the month of November. This brought the total for the year to 1,738. In comparison, the department had 1,848 calls in 2016 and 1,580 calls in 2015 for the same reporting period.

Response time average for the department was 2 minutes and 55 seconds. This is right in the departments average range.
