## City Council Roundup

### Council Issues Proclamations of Recognition

The night started off as South African emigree, Shulamit Hoffmann, was presented with the Mayor's Diversity Celebration Award. Hoffmann is the founder and artistic director of Viva la Musica!, an adult choir in Foster City. Since its inception in 2001, Viva la Musica! has performed two seasons annually of choral-orchestral multi-cultural World Music.

Mayor Frisella also read a special proclamation from the City commemorating the fiftieth anniversary of the assassination of former President John F. Kennedy. President Kennedy was tragically killed on November 22, 1963. Thereafter, Vice Mayor Charlie Bronitsky noted that the night of the meeting was the thirty-fifth anniversary of the Jonestown Massacre. Bronitsky noted that since our largest park was named after former Congressman Leo J. Ryan, who was shot that day in Jonestown and that current Congresswoman Jackie Speier was there and lied on the airport tarmac for hours, it was appropriate to have a moment of silence. Mayor Frisella agreed and called for a moment of reflection.

### Council Approves Spending \$129,000 to Design Werder & Destination Parks

Vice Mayor Charlie Bronitsky asked for this item to be pulled off of the consent agenda. Bronitsky expressed concern that spending this amount of money when the projected City budget will be a deficit in two years was a bad idea. Parks & recreation Director Kevin Miller, mentioned that the expected cost for the construction would be approximately \$2.2 million. Councilman Bronitsky expressed concern about the total costs and stated that if the Council was going to stop the project because of the cost, that this would be a good time to stop it. Bronitsky was the only dissenting vote as the measure passed 4-1.

## Economic Development - Outreach

I would like to start out by thanking all those who voted to re-elect me to the City Council. I know that the election was uncontested, but I saw your vote as a vote of faith in me and in where the City Council is going with our City. Thank you to each of you and thank you to all of the residents of Foster City for giving me the opportunity to serve for another four years.

One of the key initiatives that I feel we have accomplished during my first term was the adoption of our very first Economic Development Plan, which we call Sustainable Foster City. A key element of that initiative was a Citywide study of the retail businesses. We heard the consultant's report at the November 4, 2013 meeting and they presented some alternatives and ideas that will be among the many possible outcomes that we will consider.

The next step, as I see it, is to survey our residents, businesses and the population of people who work here in Foster City and attempt to learn why they do not shop extensively in Foster City and, more importantly, to learn what we could bring to Foster City that would cause them to shop here more often.

It was pointed out to us by the consultants, that we have a unique population. While

the 15 Acre Site, now named Foster Square. Then, Community Development Director Curtis Banks, outlined the City Staff report and the Council heard much of the Environmental Impact Report process. Some of the important points during the presentation included that; the General Development Plan will allow the development of up to 421 units of senior oriented housing (200 for-sale units, 66 affordable units, 134-155 assisted living units) and approximately 35,000 square feet of commercial space.

The purchase for the land will be a total of \$30 million. The developers, The New Home Company ("TNHC") will pay the sum of \$9 million up front and the City will carry back a loan to the developer for \$21 million dollars. The City will also lend another \$4,750,000 as part of its financial assistance for the affordable below rate housing units in the project. The monies will be lent to the Mid Pen Housing Corporation and will be paid back over 55 years at an interest rate of 3%. TNHC will also make a contribution of \$1,450,000 to the City's affordable housing fund.

TNHC will pay the City its share of the \$461,000 for improvements that are off site. These include traffic improvements and over \$3 million in park in lieu fees, which will go towards improvement of the City's parks. TNHC will also pay the City another \$560,000 for infrastructure improvements.

Brian Olin of TNHC then spoke about the project and thanked the Council and staff for their cooperation throughout the project. Olin outlined the community outreach that the company did through the Chamber of Commerce, Rotary Club, Lions Club, and through polling as well.

Olin noted that they have been watching the City's studies on retailing as they want Foster Square's retailing to be successful.

During the public comment session, William Nacht of the San Mateo Labor Council spoke in support of the project. Nacht thanked THNC for agreeing to pay all workers at the prevailing wage rate. Also speaking on behalf of the project was Joanne Bohigian, the CEO of the Foster City Chamber of Commerce.

During the Council comments, Councilman Steve Okamoto was excited about getting the project going. Okamoto also commended the EIR team for putting together a report that received no objections from either the public or any state agencies. Earlier, several staff members, including City Attorney Jean Savaree, mentioned that they had never experienced an EIR process where the agency did not receive any objections.

Mayor Pam Frisella recalled that the site had a sign saying "Future Home of Marina High School" and that once it blew down in the wind, it never went back up. The Mayor also gave credit to former councilman Ron Cox who pushed for senior housing be included in any project built on the 15 acre site. She also thanked former council members Rick Wycoff and Linda Koehling for keeping the idea alive, even though the first attempt to develop the property failed.

Art Kiesel was glad that Foster City seniors will get preference for homes at the project. Charlie Bronitsky mentioned that the project first came up when he was a planning commissioner in 2006. Bronitsky congratulated both TNHC and the City's staff for all the work that they did on the project.

## Council Corner... Economic Development

I know that the Council was already well aware of that fact, for me it brought to the forefront the issue that governments seem to make assumptions about what people want and then take action based on those assumptions. Thus, if the assumptions are wrong, then the actions taken will not have the desired results. That, for me, is what lead me to the conclusion that rather than assume what people want in Foster City, maybe we should ask those people who live and work here. That way, when we begin to discuss the solution, that solution will be driven towards meeting the real, rather than the perceived needs of our population.

By saying this I do not mean to say that I intend to step aside and let popularity rule. What I mean is that Foster City is a City of many different cultures and backgrounds and through that a variety of value systems. Thus, the City Council must first learn and understand the value systems of those cultures if what we want to do is to build a City that people of all cultures value and therefore want to make a home or run a business. To think that we already understand everyone's values is presumptuous and there is too much at stake here to be presumptuous.

I am therefore going to advocate that we take the next step of bringing together some focus groups representing various interests and try to learn why they like living or working in Foster City, what they do not like about it and how we can make it better. I strongly believe that some time spent on self-reflection in this way, will give us the best chance of succeeding with our economic development plan in ways that will enrich the quality of life for all of

us that live, work and play in Foster City.

In the coming months, you should begin to hear about the formation of these focus groups and I urge you to try to volunteer to participate in them. Participation has always been a cornerstone of life in Foster City and I hope that does not change anytime soon. I also want to open myself up more to hearing from our residents, businesses and workers and so in addition to my phone number and email address, I am also restarting my twitter account, @cbronitsky, so that those of you who use twitter can also stay involved. Starting next month I will be tweeting about things of interest to residents and businesses of Foster City, so I hope that you will decide to follow me there.

If there are other ways that you think I could be more available, please let me know. Our current Mayor, Pam Frisella, has always said that the City Council Members are the advocates for the residents and businesses and I want to continue in that vein and make myself even more available for that purpose.

Finally, I would be remiss if I did not thank Mayor Frisella for all she has done for our City and for her help to me in my personal growth as a Council Member. We did not always agree, but when we disagreed we did so professionally and always both had the best interest of our City at heart. Also, welcome Gary Pollard. I am excited for Gary to join our group and bring new ideas and new perspectives to our job. Congratulations and let's get to work!





The Gold Medal Novice Team won medals at the prestigious 2013 William Kim International Championships. In fact most of the others who won silver or bronze lost to a Gold Medal Team mate. The Gold Medal Team was comprised of mostly new competitors who are joining the Elite Development squad. "We wanted to open more opportunity for our up and coming athletes as the Team gears up for the 2014 National and Olympic Qualifiers in San Jose," explained Coach McCuin.

"We are extremely proud of our competition team and our young athletes. They performed at an extremely high. Our children do extremely well in the Olympic divisions," explained Olympic and World Champion Herb Perez. ### Exciting End to High School Football's Regular Season

#### Aragon Squeaks Out a Win Over Hillsdale In the "Battle of the Fleas"

On Friday, the Aragon Dons traveled down Alameda De Las Pulgas (translation - Avenue of the Fleas) to take on the Hillsdale Knights. Aragon has won the game for the last 21 years. However, this time, it looked like the Knights might lance their opponents. The Knights took early leads of 7-0 and 14-7. Once the Don's kicker, German Perez Meza, put a 39 yarder through the uprights to take a 17-14 lead, Hillsdale could never take the lead again.

The Dons pounded the Knights with a relentless running attack. Leading the way was Patrick Pauni who ran for 191 yards on 15 attempts, including an 80 yard touchdown run. Keith Samujh added 159 yards and rushed for two touchdowns.

For the Knights, Giancarlo Boscacci had another solid game as he ran for 116 yards on 23 attempts. Quarterback Cole Carrithers completed 14 of 34 passes for 248 yards and three touchdowns. While Shawn Charan caught two touchdowns passes and had 76 yards.

Hillsdale ends the season in first place in the Peninsula - Lake Conference with a perfect 5-0 record and is 7-3 overall. Next, the Knights will take on the Burlingame Panthers in a road playoff game next week. Aragon has conference record of 3-2 (7-3 overall) and finished in second place in the Peninsula - Ocean Conference. The Dons will now travel to Aptos to take on the 8-2 Mariners.

#### San Mateo Gets Crushed in the "Little Big Game"

For the last 86 years, the San Mateo

Bearcats have been squaring off with the Burlingame Panthers in the "Little Big Game." The Bearcats stayed within striking distance during the first half as the score was 14-0, Burlingame. After that, the Panthers continued with a non-stop scoring attack and won the game by a score of 48-0. San Mateo ends its season with a 2-3 conference record and is 4-6 overall.

#### Bothman Bulldogs Bowl Pits American River at CSM

College of San Mateo (9-1) hopes to conclude its most successful modern football campaign with a victory over visiting American River College (8-2) in the Bothman Bulldog Bowl on Saturday, Nov. 23, at 12 noon.

The Bulldogs, the No. 2 community college football team in Northern California, face off against No. 3 American River at College Heights Stadium in the most attractive of the region's seven bowl games. Only two previous San Mateo teams have won 10 games: The 1982 and 2009 squads posted 10-2 records.

State top-ranked Butte (10-0), the only team to defeat CSM this season, will play for the Northern California championship against North No. 5 Fresno City College (7-3), the Valley Conference champion, on Nov. 30. Only the title teams from those two conferences qualified for the state playoffs. American River led the Valley Conference throughout the season until falling to rival Sierra, 23-13, over the weekend.

CSM (fourth-ranked in the state) completed a 9-1 regular season, 4-1 in the NorCal Conference, with an easier than expected 54-20 triumph over visiting Santa Rosa JC (6-4), which also earned a post-season bowl berth.

## Lions Veterans Charities Delivers \$1,100 Worth of Supplies

Lions Veterans Charities, Inc. news item: On November 6, 2013, \$1100 worth of supplies were bought and delivered by Lions Veterans Charities to the USO at SFO. ## San Mateo Fire Captain Addresses Foster City Villagers at Recent Library Function

In the spring of 2013, the Foster City Library set forth to enhance its outreach and offerings to seniors within the community. And since the newly incorporated Foster City Village had a similar mission and vision, a natural collaboration soon developed. In May, an ongoing series of monthly "Lunch and Learn" programs were rolled out. The library agreed to provide both a venue and a light lunch each month, while the Village agreed to contribute the presenters and the audience. It was a true win-win from the start.

Most recently on October 30, Village members enjoyed a presentation by Captain Robert Cook of the San Mateo Fire Department who talked about home fire safety and earthquake preparedness. Cpt. Cook offered tips ranging from the wisdom of using a land line (vs. a cell phone) when making 911 calls, to the importance of having copies of vital materials (such as insurance papers and identity-confirming

documents) in the hands of out-of-town relatives, in the event of a catastrophic fire.

He also directed Village members to several excellent websites, such as firedispatch.com where - after creating a log-in account - a visitor can designate a specific address and then immediately receive notification when any emergency unit is dispatched to the given address. At www.smcready.org, Cpt. Cook noted, the public can get detailed up-to-the-minute information on recommended responses to emergencies ranging from fire, earthquakes and floods to tsunamis and pandemic flu outbreaks.

The next program in the "Lunch and Learn" series will take place at the library on Thursday, November 21 at 1 pm at which time Sergeant Corey Call of the Foster City Police Department will address the subject of home and neighborhood safety.
