TUXEDO UNIFORM CONTRACT
2018-2019

As members of the Royal Oak High School Bands & Orchestras, you are given privileges as well as responsibilities. You are given the opportunity to represent your school with the highest honor and pride. With this commitment comes the responsibility for the careful handling of your tuxedo uniform. Your tuxedo is an expensive piece of equipment assigned to you for your use during the school year. This uniform must be treated as carefully as you should care for your instrument.

Please review this contract regarding the care and use of your tuxedo. Each male student is assigned a tuxedo jacket and tuxedo pants during their fitting. Each male band or orchestra member should keep his tuxedo safely at home, to be worn for concerts and performances (as directed by his director) ONLY. Each student/parent will be financially responsible for each piece of the uniform. Damage to or loss of any part of the uniform will result in full replacement charges. Please be sure your student takes excellent care of this uniform.

Instructions for storage and use of each uniform piece:

* **PANTS** should be stored properly with the legs creased and hanging on a sturdy hanger. Pants are required to be hemmed prior to the first performance. **Do NOT CUT off the extra length!** Pants should only be worn with the dress shoes they were hemmed for. Other shoes may cause the pants to drag, and then fray as a result; damages will be charged to the student. Pants are DRY CLEAN ONLY.

* **TUXEDO JACKET** should be stored on a hanger. The tuxedo jacket is DRY CLEAN ONLY.

The tuxedo jacket and pants are made of wool. Please store carefully.

Each young man is required to wear a white tuxedo shirt (with a wing tip collar), black bow tie, and black cummerbund with his tuxedo, as well as BLACK dress socks and shoes. These items are purchased by the student for his own use; many local men's warehouse stores carry a "package" with the shirt/tie/cummerbund.

There is a \$10 dry cleaning fee, payable at the time the tuxedo is issued, for end-of-the-year dry cleaning. Students are welcome to have the tuxedo dry cleaned at their own expense as often as needed during the school year. The tuxedo jacket and pants will be returned at the last concert of the year. There is a \$25 late return fee.

It is every student's responsibility to treat the uniform with the utmost care and respect. Students and/or their parents/guardians assume responsibility for all uniform pieces issued to him. Restitution for lost or damaged uniform pieces will be the responsibility of the Band/Orchestra member and/or his parents/guardians.
