Remembering

John Bourlon

President Emeritus

July 29, 1931 — July 17, 2018



John served in the US Army for 21 years. Upon retirement, he joined the USPS in 1968. He became President of Branch 1477 in 1974 and served in that position until 1996. John also served the Branch as the Editor for several terms after he retired as Branch President.

John was instrumental in merging the 10 cities that comprise the West Coast Florida Letter Carriers. He also served on the board of the Florida State Association of Letter Carriers.

John was a devoted family man, whom seldom would be seen without his beloved wife Gerry.

When I first met John, I got the impression he got a little bit of a kick out of projecting an image of himself as some backwoods good ole boy – when he had skills and knowledge that compared with any New York City Lawyer.

Of the people, over the years, that had the chance to interact with John on

the workroom floor they will tell you:

John was a man of innate conviction and character.

He could carry the struggles of everyone around him and he had no trouble telling them how he felt about it.

If a carrier was wronged he would get in the middle of everything and just about always have the last word. If a Carrier was wrong John would ensure they would walk away making better choices in the future (or wished they had), the second time he was called upon.

John could defend and educate in the same sentence and his sentences never ran on. He was quick to speak an opinion and did so in a way that there was no doubt anyone would ever change it.

There are stories of John's antics with management, but I assure almost to a person those managers will have stories to share about the respect they have for John and respect he earned.

John taught me a lot about what we do in the positions we are entrusted. He focused on the "intent". He spoke frequently of looking beyond the words on the page and ask what was the intent of the individuals that made an agreement.

He would add "...If you have problems ask me because I wrote most of em, so I know what they mean!"

I came to the Post Office in the late 80's a little later than most that knew John. He had been the Branch President for over a decade by then. His legacy had already begun to build, my experiences with him may have been a little different than others.

It was very early in my career as a carrier that John bellowed at me the FIRST time. I can't tell you how it happened, but I turned around dumbfounded over the exchange.

A few other carriers voiced an opinion that they'd quit the Union if he talked like that to them, but even early on, I was pretty sure of two things:

- They probably already had been "talked to", and
- 2. If they hadn't they soon would be.

As a result, it made me want to get more involved in the local Union and I became a steward just a few months later.

Although that is how he appeared on the workroom

floor, if you got the privilege of knowing John at work – but at the Hall, he was different all together.

I raised my daughters, in/at the Branch functions, and John always included them. At a State Convention, he had our oldest daughter Jenny, up front leading the delegation (at the age of 8) in the National Anthem. He had promised her ice cream and over the years she talked him out of 2 or 3 sundaes as he would continue to act like he hadn't paid up.

John once tossed Stephanie, our youngest, (then 15 with learners permit in hand) the keys to his truck for her to move it across the Hall parking lot. I still remember this gangly teen climbing up in that big ole Dually pick-up normally used to pull his 5th Wheel.

John liked them around and I think he wanted to make sure I stayed around because of them.

In 1995 a Board position opened up for Treasurer. Before he offered to appoint me between elections, John called my wife Karen, to ask if it was OK he asked more time of me. He told her it would only be about 10 hours a month away from the house. It ended up being a lot more. It was closer to 10 hours a week. Anyone that has held a position with John in charge can attest, there were always more hours involved.

John stepped down as president soon after, turning over the Branch to other hard-working men and women that he had mentored.

John continued to serve the Branch as the Editor. By then, I was either a full-time officer or spending much more time at the hall. He'd stop by daily just to talk. I found myself dreading another story but always found myself totally captivated in the content or the delivery. I could just never walk away.

John liked to talk and debate and win. When the Branch relocated to the Pinellas Park building, there was some discussion on spending money for furnishings.

John spoke against it and I in favor of it. The following day John showed up at the hall, he had cut off the pony tail, shaved his head he told me "When I Grow Up I want to be just like you"

And all the time I was just trying to follow his footsteps.

John was my go-to before any important event in the Branch, he was an advisor, a mentor and a friend. He was pretty proud he had a Grandson hired as a CCA and constantly questioned me on his progress not only as a letter carrier but his climb to Full-Time – it got a little annoying!

As a result of the deep respect and admiration for John by the members of Branch 1477:

Named John President Emeritus of Branch 1477 In 2009, and in 2015, dedicated The Branch 1477 Hall in his honor.

John was respected by many and loved by more, he will be missed. He will continue to inspire those who knew him.

Identifying Intentional False Editing of Clock Rings

At the National Convention, Christopher Jackson, Director of City Delivery, presented a guide created to assist stewards, carriers and city carrier assistants in identifying violations when management falsely edits clock rings. On a daily

basis, supervisors edit carriers' clock rings to fix errors or omissions as recorded in the actual time figures recorded in (TACS). Such editing is necessary to fix incomplete clock ring entries and/or lack of moves by carriers from one function or a route. When these time entry errors are noticed, supervisors should change the time in (TACS) to reflect when the clock ring should have been made. While the editing of a carrier's clock rings in these situations is proper, management must ensure their edits are accurate.

In some cities across the country, NALC has recently become aware of some occurrences of intentional false editing of carrier clock rings. In most instances, managers were deliberately changing the end-of-tour clock rings made by carriers to reflect an earlier time when they were actually still working. These edits ranged from just a few minutes to several hours, and resulted in carriers not being paid for time they actually worked. Throughout the cities where this took place, carriers as a whole were shorted tens of thousands of dollars in pay.

In addition, the NALC has created a "Work Hour *Tracker*" for each carrier to use to keep track of their hours. The tracker contains 52 pay periods worth of fillable tracking forms; a detailed instruction page that explains how to properly track hours and figure overtime for full-time regular, part-time flexible and city carrier assistant (CCA) letter carriers; a USPS calendar and time conversion table. It even has a page for each pay period to take notes, where carriers can record things that occurred during that time frame. Such as which routes they carried, if they took a lunch for more or less than 30 minutes, if they left early to go to a doctor's appointment, when they took annual leave, etc. These notes could be invaluable if it's determined after the pay period is over that an edit to clock rings resulted in a loss of pay.

The Work Hour Tracker is available on the NALC Member Mobile App. After opening the App, click the search bar, then on the right, select "Members Only".

Seven days a week, carriers work hard delivering the Nation's mail and they deserve to be fully compensated for every minute of that work.

What to do when served a discipline letter

Don't delay submitting the Discipline notice to your immediate shop steward or the union hall. An employee or union representative has 14 days to gather information to discuss the grievance for the discipline with the carrier's immediate supervisor. Don't assume management has already informed the union of your disciplinary letter.

The grievance needs to be handled in

a timely manner. The grievance procedure gives every letter carrier the right to make sure their point of view is heard and understood. The first initial stage of a grievance is the Informal Step A. In this step the employee or union representative meets with the employee's immediate supervisor. On the Informal Step A meeting date, the individual grievant participation is

neither required nor prohibited.

Presidents Report:

No Stewards meeting this month due to National Convention but please update your lists of OJI's (On the Job Instructors) Safety Captains, CFC and Customer Connect with current list left in your boxes.

CCA Training/Scheduling/ Treatment
The NALC and USPS recognize the importance of
providing quality training to new city letter carriers.

City carrier academies will be established in all USPS districts and use the Standard Training Program. It is our expectation that the parties at all levels of each organization will work cooperatively to ensure all aspects of the training be completed.

Each USPS district will provide a list of prospective city carriers to the NALC National Business Agents as early as possible.

Can CCA's be required to remain on stand-by or remain at home for a call in on days they are not scheduled? The answer is NO.

Leadership Academy consists of 3 week long sessions over a 5 month period. In addition they are required to complete a project based on the curriculum covered and be approved by Academy staff. Applicants must be endorsed by a union leader who commits to be their mentor throughout the process. Hundreds apply but a small number are selected to attend the Leadership Academy. Usually participants have to apply multiple times before being selected. Branch 1477 in the past has had 3 accepted to attend. I am pleased to announce that First Vice President Zulma Betancourt has been selected starting her first week on July 29th—August 3rd, 2018.

Detroit Convention—we're sending 22 paid delegates from the branch. 7 attending their first Convention and 5 started as CCA's. Retiree Susan Chavez will cover the hall while we're gone.

The very first Union was formed in Detroit.

We have an Amendment sent to National concerning the 4 month rule allowing a 204b to resume back to their route. This resolution would eliminate that and not hold routes for 204bs.

Form 1723 used for 204b's assignment, watch for

any surprise 204b back carrying mail in your zone.

We have updated lists of every CCA and their zip code location.

Possible Parcel Post test site for Parcel Post delivery. Several criteria have to be met to qualify. Deadline is the 25th for this process.

Retiree Update

It is

with much sadness that I report that my good friend, John W. (walks like a duck) Bourlon passed away on July 17, 2018.

John entered the Postal Service in 1968, and soon after entering, he became angered at the mistreatment of Letter Carriers by Postal Management and became proactive in the Union and began serving the members of Branch 1477, first as a Steward, then Chief Steward and then in 1974, as President until his retirement in 1996.

During his presidency, he set Branch 1477 on the path to becoming, for the first time, a strong Union, forging the merger of the ten cities which currently comprise Branch 1477. He provided outstanding leadership and training to the Officers and Stewards of the Branch. He zealously enforced the contracts, both Local and National, standing up to Postal Management, and doing everything in his power to protect the rights, entitlements, and dignities of all members of Branch 1477.

His foresight in forging the present merged Branch 1477 was key to providing the Branch with the necessary resources to have full time officers who could "be on call" "24/7" to address problems and represent carriers without first getting permission from Postal Management. Those resources provided the means to provide the continuing education and training of the Stewards and Officers, which, in turn, contributed to Branch 1477 becoming highly successful in representing the members, in grievances at all levels, in EEO cases, and Workers Compensation claims.

John was most instrumental in the purchase of land and building our former Union Hall at 66th St. N., Largo which served the members from 1976 through 2001 when it became the centerpiece of a negotiated deal which brought us the present Union mortgage free. This hall Blvd, Pinellas Park was dedicated in honor of John in November 2014. This dedication came about because of a discussion during our Largo Retirees monthly breakfast. Some of the retirees were talking about what the Union meant to the carriers. One of them piped up and said, "Hell, we didn't have a Union until Bourlon. Before him, it was just a social club." He said "we ought to name the hall after John." I told him if someone would draft a Resolution to that effect, I would bring it to the membership for a vote. A Resolution was written,

presented to the membership for a vote, and unanimously adopted. We had a big celebration ceremony in Nov. 2014, in which over 400 people attended, including our National President, Fred Rolando. That dedication is commemorated by a metal plaque on the front of the building naming it THE JOHN W BOURLON (If It Walks Like a Duck) UNION HALL.

Although John was known to be a pain in the rear by most of Postal Management, almost to a person they respected him. They respected his passion for standing up in defense of letter carriers. They also found and respected that his word was his bond.

John was well known, respected, and loved by the carriers of Branch 1477. He was also well known, respected and loved by many carriers throughout the State of Florida. He served on the FSALC Board for over 25 years. During those years, he was called upon to teach many classes. He was also called upon by Presidents of various Branches for advice and assistance. He never turned anyone down when called upon.

John and I served together at every State and National Convention from 1975 until his last Convention in 2008. Conventions, as well as most legislative bodies end their sessions with a Latin term that roughly means, "until we next assemble". So I won't say goodbye to my good friend. Instead, I will say "Sine die, my Union Brother".

- Stand up talk (minutes)
- Safety talk (minutes)
- Customer Caller Service
- Excessive parcels (the number of parcels above adjusted base)
- Heat/ Humidity
- Physically not feeling 100% (12th consecutive day worked)
- Unfamiliar with route
- Route has construction (line of travel)
- changes daily)
- Reported to case with mail cased
- Thin Mail
- Thick Mail
- New route line of travel (unfamiliar)
- New deliveries (since adjustment)
- Deviation for Express Mail
- Lengthy Workhour/Workload Discussion
- Spent (minutes) on Union Time meeting with Steward
- First day back from vacation (need to verify holds and moves on street)
- Verify Hold Mail (N/S yesterday)

Remember anything that slows you down can be entered in Box J. Always ask for the time you need and use what you ask for!

Breast Cancer Facts:

One in eight women will get breast cancer. In fact, breast cancer is the second leading cause of cancer death in women. With numbers like that, every

woman should get screened.

The good news is, today there are fewer women dying from breast cancer. This is likely because mammograms are helping women find cancer earlier, when it's easier to treat.

What exactly is a mammogram?

A mammogram is an x-ray of the breast. It checks for lumps or tumors. During a mammogram, your breast is placed between two plates. The plates flatten the breast for a few seconds so the technician can take a quick x-ray. This simple x-ray can spot breast cancer in its early stages, making treatment easier and more successful.

Who should get a mammogram?

Women age 50 through age 74. You should have a mammogram every two years.

If you have risk factors, a family history of breast cancer or other factors may mean you need a mammogram – even if you're under 40.

If you have not had a mammogram within the past two years, please schedule your mammogram today.

The NALC Health Benefit Plan covers certain preventive care, like mammograms, at 100 percent when services are rendered by a PPO provider.


