Albertson moved, Sparrow seconded, to pay bills as listed. Motion carried.

Old Business:

Third Reading of amendments to City Ordinance 348:

Section 7.0210 Water Service – Construction of – Maintenance of by Owner to read The cost of original installation of all plumbing between the main and any service devices maintained by the property owner and all extensions made to such plumbing, as well as all repairs, shall be borne entirely by the property owner, although such plumbing and services as well as the meters shall at all reasonable times be subject to inspection by duly authorized representatives of the municipality. Any repairs found to be necessary by such representatives shall be made promptly, or the municipality will discontinue service.

The property owner is responsible for the water service lateral which connects their property to the water main in the street. The connection to the water main is a part of the water service lateral and is also the property owner's responsibility. The property owner is required to fix any improper connections.

All services shall be constructed by licensed plumbers at the property owner's expense, and each service shall be maintained and repaired by the property owner. Services heretofore acquired by the issuance of special assessment warrants and assessed against the property, or which may be acquired in the future in like manner, shall likewise be maintained by the property owner. Services means the service line running from the point of connection with the city main to the property owner's premises.

Section 7.0301 Purpose and Definitions to read It is the purpose of this article to provide ordinances regulating the use of public and private sewers and drains, private sewage disposal, the installation and connection of building sewers, and the discharge of waters and wastes into the public sewer system, and to provide penalties for violations thereof, in the City of Rolla, North Dakota.

Sewer Main Line is defined as a utility pipe that carries wastewater from a property's sewer lateral to the lagoon, via a sewer force or gravity main.

Sanitary Sewer Lateral is defined as a pipe that carries wastewater from a property to the sanitary sewer main line in the street. Every property receiving sewer service from the City has at least one sanitary sewer lateral.

Section 7.0309 Sewer Service - Construction of - Cost- Maintenance of by Owner to read

- The property owner is responsible for the sanitary sewer lateral which connects their
 property to the sanitary sewer main in the street. The connection to the sewer main is a
 part of the sewer lateral and is also the property owner's responsibility. The property
 owner is required to fix any improper connections, such as roof drains, downspouts,
 driveway drains, foundation drains, or sump pumps, connected directly to the sanitary
 sewer.
- 2. The cost of original installation, as well as repairs, shall be borne entirely by the property owner.
- 3. The property owner is responsible for the maintenance and repair of the sanitary sewer lateral.

Vollmer moved, Albertson seconded, to approve the amendments to City Ordinance 348. Motion carried unanimously.

Moore Engineering's 2018 Water Treatment Plant Technical Service proposal will be considered at the June 20th meeting of the city council.

Albertson moved, Sparrow seconded, to reimburse the Rolla Park Board, up to \$5,900 for an ice skating rink (use remaining Horizons funds). Motion carried.

Committee Reports:

Engineering:

Vollmer moved, Gottbreht seconded, to accept Keller Paving's Change Order #2 on the 2017-1 Street Improvement Project, increasing the contract by \$1,312.50, and adding 12 days to the contract. Motion carried.

Albertson motioned, Hemmy seconded, to approve Rolla City Attorney, Michelle Gibbens' option #2 – to write a letter to American General Contracting explaining the cities' planned course of action for final payment on the water treatment plant contract. AE2S Water Treatment Plant Performance Coaching proposal will be considered at the June 20th meeting of the city council.

Public Works:

Committee minutes and Directors' reports submitted.

Police:

No minutes submitted.

Hemmy moved, Albertson seconded, to order new phones for the police department (Verizon contract allowed for four free upgrades). Motion carried.

Hemmy moved, Albertson seconded, to purchase four tools to unlock car doors. Motion carried.

Sparrow moved, Hemmy seconded, to purchase four new police badges at \$80.00 each. Motion carried.

Administrative:

Administrative Committee did not meet in May.

Amend Section 5.06 if the City Policy Manual as recommended by the Administrative Committee to read: Permanent full-time employees will accrue sick leave at the rate of 8 hours, and permanent part-time employees will accrue sick leave at a proportional rate, for each full month of employment.

Amend the second sentence of Section 5.08 of the City Policy Manual -Retirement, to reflect the correct employer and employee contributions to read: Employees meeting the 20/20 rule shall contribute 5% of their gross wages, and the Employer shall contribute 10.26% of the employee's gross wage to the employees' retirement plan in accordance with the cities' PERS agreement.

Albertson moved, Vollmer seconded to amend sections 5.06 and 5.08 as recommended by the Administrative Committee. Motion carried.

Albertson moved, Gottbreht seconded, to consolidate the Rolla Community Center bank accounts with the cities' primary bank account. Motion carried.

Cemetery:

No report submitted.

Albertson moved, Hemmy seconded, to approve the committee reports. Motion carried.
