


TOWN OF PREECEVILLE

A BYLAW OF THE TOWN OF PREECEVILLE TO AMEND BYLAW NO. 6-2016,
WATER AND SEWER RATES

NOW THEREFORE, the Council of the Town of Preeceville in the Province of Saskatchewan, in an open meeting assembled enacts as follows:

1. Delete Section 14 "...if any charges are unpaid one month after billing, interest at the rate of 1 ½% per month will be added to the unpaid balance."
2. This bylaw will come into force, and take effect, on the day of approval by The Saskatchewan Municipal Board.

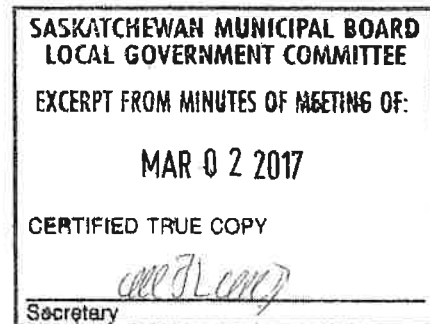
