TITLE: Approval of Security Deposit and First Month's Rent Assistance Policy

- WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and
- **WHEREAS**, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and
- WHEREAS, the 2021 Indian Housing Plan (IHP) states the Summit Lake Tribe will provide the Sports Registration Fee and Sports Equipment to eligible youth tribal members; and
- WHEREAS, Policy Handbooks for the Housing Program were created by the Tribal Council and staff to provide the personnel responsible for the Housing Program with an outline for program implementation; and
- WHEREAS, The Tribal Council proposes the following Summit Lake Paiute Tribe's Security Deposit and First Month's Rent Assistance Policy, to enable the tribe to meet the Indian Housing Block Grant (IHBG) requirements; and
- WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt Security Deposit and First Month's Rent Assistance Policy in an effort to aid eligible tribal members with over-crowding and with aiding the tribal members with independence and self-sufficiency; and
- NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada hereby approves the adoption of the Summit Lake Paiute Tribe's Security Deposit and First Month's Rent Assistance Policy.
