❖ Orders were approved and signed by the Board unanimously for the Treasurer.

Minutes from February 16, 2021:

❖ Minutes from February 16, 2021 were approved and signed by the Board unanimously.

Dan St.Cyr-Clark's Truck Center:

- ❖ Dan St. Cyr was invited to the Board meeting to talk about the possibility of leasing 3 new trucks for the Town. Each truck was reviewed and discussed.. After a long discussion with the Board members and the Road Commissioner, Dan left the meeting to allow the Board and Road Commissioner to discuss their thoughts on this matter.
- ❖ The Board and the Road Commissioner continued to review the financial impact of leasing versus hourly rental and realized there would be significant savings by accepting the lease offer made by Dan. They decided to lease two trucks now and have further discussion regarding the lease date of the 3rd truck. The Board contacted the salesman, Dan, shortly after he left and told him of their decision. Alden and Darren agreed to follow up with Dan to review the contracts again before ultimately signing them. More details of this transaction will be updated at the next meeting.

Other Business:

Alden Warner

- ❖ Priscilla joined the meeting via skype, and then later by speaker phone, due to connection complications with skype, to discuss the Town Budget. Presently the road budget is showing more than a \$26,000 loss and there is concern regarding asking the town for an increase in funding, especially now with the Covid 19 situation causing monetary concerns for so many. Leasing the trucks will bring some financial relief, but presently there is uncertainty of the actual date the trucks wills be available. It was decided to offer insurance benefits to employees only, effective April 1st, to help relieve the road budget loss by about \$6,000. It was determined this could be an option because policy states insurance benefit changes can be mandated by the Board at any given time.
