Data Modernization Sharing Provisions Clarifications

Jennifer Schultz met with Suzanne Arntson (Scott County Child Welfare Manager) and Jeanne Andersen (Scott County Senior Attorney) in regards to the release of information. When releasing information between Scott County divisions, there is no need for the release of information. However, when releasing information from organization to organization, there is a need for the release of information.

<u>Action</u>

- Kirt Briggs, Jennifer Schultz, Sarah Geffre, and Kami Thompson gathered to create a potential action proposal that could be presented to the 50x30 Executive Board.
 - The action proposal must reflect a positive impact on the community along with creating a meaningful difference amongst the youngest generation in reducing Kindergarten surprises and increase third grade reading fluency.
- Lisa Brodsky presented the Education Preparedness Logic Model, which includes the problem statement, the long term goal, and the objectives to accomplish the long term goal of ensuring children are developmentally on track and prepared for educational success through the assistance of education, health, and clinics.
- For reference, Early Education Screenings <u>DO NOT</u> need to be completed by the age of three. However, the recommended age to have an Early Education Screening completed is the age of three.
- Kathy Nielsen asked for support in moving on with Early Education Screenings as the first action step, in which the majority of the working group agreed.

Homework

- Kathy Busch and Commissioner Weckman Brekke will work together to generate a list of questions that will be presented to the school districts within Scott County in regards to Early Education Screenings along with obtaining results of those screenings.
 - O What are schools doing well?
 - What tests and evaluations are available for Early Education Screenings? What are the implications of instruments?
 - For those districts that are not performing as well as others and getting their desired results, what are the barriers?
 - o Are all districts screening the same way? Are all districts using the same state standardized screening?
 - o Who performs Early Education Screenings? Teachers? Nurses? Para-Professionals?
 - How do districts communicate to their geographical region that Early Education Screenings are required prior to Kindergarten?
- Kathy Busch will bring in an example of the MPSI (Minneapolis Preschool Screening Instrument).
- Kami Thompson will be contacting the Minnesota Department of Education to inquire as to whether or not screenings can be mobile.
