#### January 10, 2024

The meeting was called to order by Mayor Patrick Edwards at 7:00 p.m. at Thomas Jefferson Elementary. Roll call: John Bartello, Cathi Fouts, Kathryn Strumpell, and Bartello to approve the agenda. Motion carried 4-0.

### Old Business:

a. City Clerk, Jenny Michael, submitted her letter of resignation dated January 10, 2024. She will transfer equipment and records and assist the appointed city clerk as needed. Bartello motioned, seconded by Mason Strumpell to accept Michael's resignation. Motion carried 4-0.

### **New Business**

- a. Bartello motioned, seconded by Mason Strumpell to accept the 2024 Employment Agreement with Caldwell & Brierly, PLCC. Out of court per hourly rate will increase from \$195 to \$200; in court hourly rate will increase from \$220 to \$225. Motion carried 4-0.
- b. Bartello motioned, seconded by Kathryn Strumpell regarding the Memorandum of Agreement with Clean Energy Districts of Iowa (CEDI) with no financial funding. CEDI is working with cities opposing Alliant Energy's price increases. Motion carried 4-0.
- c. Mason Strumpell motion, seconded by Bartello to hire Amanda Bode as the city clerk with a monthly salary of \$600. Motion carried 4-0. Michael will work with Bode for training as needed, transferring equipment and records, and updating Bank Iowa, US Bank, and credit card accounts.
