# **GENERAL MANAGER'S REPORT**

September, 2022

I trust everyone had a great summer at the lake! Blue Ridge Shores has so much recreation to offer, and I hope all our members take advantage of the lake, beaches, trails, courts, and common areas.

I am working with our security contractor to work out bugs with the gate and apologize for the continued issues. The gate arm is much more expensive, so please do not tailgate as it will only allow one vehicle to go through.

The Roads within Blue Ridge Shores have been adopted by Louisa County for traffic enforcement. After completing some signage updates, the sheriff's department has agreed to do routine patrols. Please be aware that you can receive traffic violations within Blue Ridge Shores, just like any public road.

Our administration office and maintenance team work hard to meet the needs of the community. If you have any questions, concerns, or suggestions, please contact me! I truly enjoy talking with members about the community.

# Please help keep our community looking great!

One of the most common bylaw violations is for old vehicles and boats kept on members property after their useful life. They distract from the beauty of the community and are an environmental risk to the lake. We don't want vehicles rusting away or dripping fluids.

Our bylaws state:

2. Inoperable and Inoperative Vehicles:

A legally inoperable motor vehicle is a motor vehicle that is not legally operable on public roadways and includes a motor vehicle that is required to display but does not display a current Inspection Sticker or a license plate with current decals. Current registration and state inspection shall be furnished upon request by the Office.

An inoperative motor vehicle is a vehicle that is not in operating condition.

- (a) No legally inoperable or inoperative motor vehicle that is visible by someone standing at ground level from outside the property on which the vehicle is parked shall be parked on any lot in the subdivision.
- (b) No legally inoperable or inoperative motor vehicle shall be parked on any street or common property in the subdivision.
- (c) The usage of a vehicle car cover will not satisfy the intent of this policy.

Please evaluate your property. If you have any old vehicles or boats, you can usually find a company to pick them up at no charge or even get some cash for them!

# BLUE RIDGE SHORES PROPERTY OWNERS ASSOCIATION RULES OF OPERATION FOR GOLF CARTS 2022

- 1. Golf carts are limited to a self-propelled vehicle that is designed to transport persons playing golf and their equipment on a golf course.
- 2. All golf carts must be registered with the Association and obtain an ANNUAL DECAL. The 2022 decals are available and the annual fee is \$50.00.
- 3. Owners must provide evidence of insurance at Virginia minimum and maintained in the golf cart at all times.
- 4. Operators must possess a valid state driver's license.
- 5. Owners must comply with all laws pertaining to the use and possession of alcoholic beverages.
- 6. Only the number of people the golf cart is designed to seat may ride in the golf cart. Passengers shall not be carried on the part of the golf cart designed to carry golf bags or other equipment.
- 7. Golf carts shall be operated to the extreme right of the roadway and must yield to all vehicles and pedestrian traffic.
- 8. Golf carts shall be operated only between sunrise and sunset, unless equipped with such lights as are required in Section 46.2-1010 (Virginia Code).
- 9. Golf carts shall not be operated during inclement weather or when visibility is impaired by weather, smoke, fog or other conditions.
- 10. Golf carts shall display a slow-moving vehicle emblem in conformity with Section 46.2-1081(Virginia Code).

JUST A REMINDER: Quarterly water bill payments are due for the following quarters by the dates listed:

3rd qtr. Due by October 31st Disconnects are 11/15/22

4th qtr. Due by January 31st Disconnects are 02/15/23

If you do not receive your bill by the 10th of October for 3<sup>rd</sup> quarter or 10<sup>th</sup> of January for 4<sup>th</sup> quarter, please call our office at (540) 967-1408 for a replacement bill. Failure to receive your bill does not relieve you of your obligation to pay for water bill or any late charges that may incur for past due accounts. Once water is disconnected, **there will be a \$50 fee to reconnect**.

If you need assistance with payment arrangements, you must contact our office prior to the due date.

Past-due/Disconnects for  $3^{rd}$  quarter are sent by 11/1/2022 for any account that is not paid by 10/31/2022.

Past-due/Disconnects for  $4^{th}$  quarter are sent by 2/1/2023 for any account that is not paid by 01/31/2023.

#### **MARINA GAS SALES**

You may buy your gas by going to the office and obtaining a key fob. This fob will allow you to prepay for gallons of gas. After prepaying for the gas during office hours you can then use the fob at any time to fuel your boat with gas.

**A reminder** on reporting items that require attention but are not life-threatening situations once the Office is closed. Please call Louisa County Central dispatch, 967-1234 to report the following (examples):

- Water Leaks
- 2. Gates not working or a broken gate board
- 3. Tree down blocking a road
- 4. Items in the lake or loose boats
- 5. Problems with a boat located in one of the marinas
- 6. Lost & Found Animals

This is Standard Operating Procedure. Once the dispatcher is contacted, they will notify appropriate BRS Staff Members to respond.

# **Marina & Boating Safety**

# **Electric Shock Warning**



Boats can be a great source of summer fun and leisure, but boaters and swimmers must be aware of dangers in and around the water. Electrical hazards bring unique risks to the boating world. Learn to protect people and pets from these dangers.

#### **KNOW THE RISKS!**

Electrical shock drownings can occur when marina electrical systems leak electrical current into the water. Boats can also serve as the source of an electrical leakage. Leakage can cause a shock that can injure, disable, or kill a person.

Never allow swimming near a boat that is plugged into 110v, in a marina, or at the launching ramp. Residual current could flow into the water from the boat or the marina's wiring. This can put anyone at risk of electrical shock drownings (ESD).

Be sure your boat is well maintained. Have it inspected each year. Ask a qualified marine electrician to do this job.

If you have electric on your dock, Ground fault circuit interrupters (GFCIs) and equipment leakage circuit interrupters (ELCIs) should be installed and tested monthly. Run tests to find out if electrical current is leaking from the boat.

Only use cords intended for marine use. Never use household cords near water.

Know where your main breakers are on both the boat and the shore power source. This will help you respond quickly in an emergency.


