Lakehead University and NOMA regarding the Immigration, Refugees and Citizenship Canada reforms to the International Student Program; and

FURTHER BE IT RESOLVED THAT The Corporation of the Town of Rainy River requests that the IRCC reconsider the current approach to the cap on international student permits and participate in open dialogue with NOMA, Lakehead University, Confederation College, the Thunder Bay Chamber of Commerce, and other key stakeholders to explore solutions that recognize the unique challenges faced by institutions in northern regions; and
