**Salute to the Flag / Regular meeting call to order:**

EAD's Group Representatives Thomas Kakabar, Renae Kakabar and Steve Mitchell, Gina Bianucci representing Mainline Newspapers, Larry & Brenda and Mike Marsh also attended the meeting.

**Public Participation:**

Larry Marsh

- Presented to the Supervisors the Adjacent Lot Merger Plan for Larry E. Marsh ET UX. Reviewed by the Solicitor and Supervisors, approved by the Cambria County Planning Commission. The plan meets all of the requirements set forth in the Township's Subdivision and Land Development Ordinance.

**Motion** made by Raymond Guzic, Jr., 2<sup>nd</sup> Scott Guzic to accept the Adjoining Lot Merger Plan for Larry E. Marsh ET UX as presented. Roll call, all in favor, Motion passed.

- Adjoining Lot Merger Plan needs to be notarized and recorded at the Cambria County Recorder of Deeds.
- DEP also authorized on lot sewage disposal system.
- Driveway pipe to be installed weather pending- may wait until spring 2020.

**Secretarial Report:**

EAD's Group

- Engineer suggests itemizing stormwater management cost in our annual budget. Stormwater management is becoming more of a financial burden on townships. A history of stormwater expenses and storm water preventive maintenance needs to be recorded for future grant/assistance income dealing with stormwater runoff.
- Park Road- Water project connection at Memorial Drive, trees have been trimmed/removed, the project is moving along rapidly. One property owner has not

authorized an easement for the project. A written response to his questions has been complied; letter to be sign by chairman, EAD's Engineer to hand deliver this letter of correspondence from the Township, regarding the answers to the property owners questions.

- The Engineering Agreement between The EAD's Group and Washington Township. New agreement- due to then township being a recipient of two grants: The Greenways, Trails and Recreation Grant and also the Marnier East Grant Fund. Costs for engineering fees have changed with the combination of the two grants.

- Park Road Water lines specifications have been upgraded from using SDR18 up to SDR 14 a thicker pipe.

**Motion** made by Raymond Guzic, Jr., 2<sup>nd</sup> Scott Guzic to accept the 2019 Greenways, Trails and Recreation Grant in the amount of \$247,350.00; pending Solicitor review. Roll call, all in favor, Motion Passed
