

ORDINANCE NO: 13 – 1086

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE LOGAN COUNTY SHERIFF’S OFFICE TO ADMINISTER A LEADS PROGRAM IN COOPERATION WITH THE VILLAGE OF RUSSELLS POINT POLICE DEPARTMENT AND DECLARING AN EMERGENCY IN THE VILLAGE OF RUSSELLS POINT, OHIO

WHEREAS, the Logan County Sheriff’s Office maintains dispatch records and software from CivicaCMI Inc. & Cisco-PS Inc. and provides dispatching services for the Village.

WHEREAS, both parties agree that a common data base of records, such as crash, stolen property, dispatch and incident reports are a valuable shared asset.

WHEREAS, the Village of Russells Point will agree to pay the sum of \$1000.00 per year, not to exceed five years, for use of the CivicaCMI RedHawk software.

WHEREAS, the Logan County Sheriff’s Office will maintain the training credentials and records required by LEADS.

WHEREAS, the Logan County Sheriff’s Office reserves the right to suspend use of the RedHawk Software for improper or illegal use.

WHEREAS, the Logan County Sheriff’s Office will host the CivicaCMI, Inc. RedHawk on their server under the following conditions:

- a) Any costs associated with securely accessing the database (Internet connection, VPN software, etc.) is to be borne at the expense of the Village.
- b) Database back-up tapes maintained will be stored by the Sheriff. Copies of the database may be obtained, but no more than once per month. The cost of the back-up tapes and materials shall be borne by the Village.
- c) Expungement requests are the responsibility of the Village of Russells Point Police Department.

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the Mayor to execute any documents necessary to enter into this agreement is necessary and in the best interest of the Village of Russells Point;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Russells Point, Ohio:

SECTION I: The Mayor is hereby authorized to execute any documents necessary to enter into an agreement with the Logan County Sheriff’s Office to administer a LEADS program in cooperation with the Village of Russells Point Police Department.

SECTION II: The Village Fiscal Officer is hereby directed to make the necessary annual payment of \$1000.00, not to exceed five years, to fulfill the Village’s obligation under the agreement.

SECTION III: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this council and that all deliberations of this Council, and any of its committees that resulted in such

formal action, were in meetings open to the public in compliance with all legal requirements of the Ohio Revised Code.

SECTION IV: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety in the Village of Russells Point to continue to provide public services to the Village. This ordinance shall go into immediate effect provided that it receives a two thirds vote of all members of Village Council.
