

## DAYCARE AND FACILITY USE AGREEMENT OF LIABILITY

- 1. I understand and agree that Dog World Daycare and Behavior Center, LLC (Herein after referred to as Dog World) and its members, owners, managers, employees, and agents will not be liable for problems, damages, or injuries caused by my pet during its visit at Dog World. I, as the pet owner, agree to be solely responsible for any and all acts or behavior of my pet while in the care of Dog World. I hereby release and agree to indemnify and hold harmless Dog World from any liability arising from my dog's attendance and participation in any Dog World daycare and/or play sessions.
- 2. I understand that Dog World daycare and open play areas are places where animals co-mingle in groups. I recognize that there are inherent risks of illness or injury when dealing with animals. Similarly, I understand that when dogs play in groups, they may sustain injuries such as nicks and scratches. I understand and agree that any problem or injury that develops with my dog will be treated as Dog World deems best at its sole and absolute discretion. Dog World staff may wait until I pick up my pet to inform me of any non-serious injury, such as nicks and scratches. In the event my pet becomes ill or injured to the point of requiring medical treatment, Dog World will first attempt to contact me, followed by an attempt to contact the emergency contact listed on the enrollment form. If the circumstances are deemed at its sole and absolute discretion, such that immediate treatment is necessary, Dog World may attempt to contact my pet's veterinarian. In the event my pet's veterinarian is not available, a veterinarian will be chosen by Dog World. Dog World retains sole discretion to deal with emergency matters, and I agree to promptly pay for all medical treatments received by my pet.
- 3. I understand that Dog World open play areas are places where animals co-mingle in groups. I recognize that there are inherent risks or illness or injury when dealing with animals. Similarly, I understand that when dogs play in groups, they may sustain injuries. I understand and agree that any problem or injury that develops with my dog is my responsibility.
- 4. I understand that I am responsible for any harm caused by my dog at Dog World, whether to dogs or human patrons or to Dog World staff. I shall indemnify and hold Dog World harmless against any claims made against Dog World or losses or damages of any kind suffered by Dog World as a result of my pet, its behavior or condition, or my failure to inform Dog World of any pre-existing condition my pet may have including but not limited to (such as illness or aggressive tendencies). I understand and agree that in admitting my dog to Dog World, Dog World's staff has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.
