Booe House roof replacement 3-15-23.
Scott: Sullivantown sewer project may start with fencing tomorrow.
Finish project in 3 weeks.
Peggy: Did you let the school know?
Scott: Yes.
Mark and I met with DOT to discuss the sidewalk around REVO Church.
Survey for sewer lines \& water lines to start soon.
Wesley: How close to the building?
Scott: The sidewalk will be pretty close.
Peggy: Isn't there a pole there?
Scott: Moved for intersection improvements. Will add to parking.
Doc: Will the backside of the building be paved for parking?
Scott: If council decides to.
Peggy: Ceiling?
Scott: Left for tenant to replace.
Community Meeting space parking lot has increased.
Peggy: It is 3 times bigger than the building.
Wesley: Maybe REVO can use it since they will lose parking because of the sidewalk.
Scott: Let date should be the end of April.
Doc: I see no reason to delay. We'll review at the workshop.
Peggy: I'd like to see the plans again.
Doc: Are you getting estimates for the HVAC units?
Scott: Yes.

Davenport is working on traffic needs at the Walkertown Commons / shopping center intersection.
Wesley: Who owns the interior roads at the shopping center?
Scott: The owner of the shopping center.
Doc: Any other questions from council? NO.
