

Articles of Incorporation  
Of  
Herndon High School Guitar Boosters, Inc.,  
A Virginia Nonstock Corporation

The undersigned, pursuant to Chapter 10 of Title 13.1 of the Code of Virginia, states as follows:

ARTICLE ONE

Name

The name of the corporation is: Herndon High School Guitar Boosters, Inc. (hereinafter referred to as "the Corporation").

ARTICLE TWO

Purposes

The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501 (c)(3) exempt organizations. To this end, the corporation shall:

Provide support, financial and otherwise, to the Herndon High School Guitar Program ("HHS Guitar Program") including, but not limited to, raising funds for expenses and the support of the activities of the HHS Guitar Program.

Serve as a liaison between the HHS Guitar Program and the Herndon High School administration, faculty, students, parents and community.

Promote school and community support of the HHS Guitar Program.

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE THREE

Members

The Corporation shall have one or more classes of members with such designations, qualifications and rights as set forth in the bylaws.

ARTICLE FOUR

Dissolution

Upon dissolution, all assets of the Corporation will be conveyed to the Guitar Program within the Music Department of Herndon High School. If the Guitar Program at Herndon High School no longer exists at

that time, all assets of the Corporation will be conveyed to the Music Department of Herndon High School.

ARTICLE FIVE  
Board of Directors

The Board of Directors shall manage the affairs of the Corporation and shall be composed of directors and officers. The number of directors and officers shall be set forth in the Corporation By-laws. The directors and officers shall be elected by and from among the voting membership for a term in accordance with the By-laws.

The Herndon High School Guitar Director is an ex officio member of the Board of Directors.

Registered Agent
