

SDRA General Membership Meeting

President Chuck Hamlin called the meeting to order at 1:22pm at the Governor's Inn in Pierre, SD. He introduced the new directors and review meeting procedure.

Secretary Anderson review the financials for the 2023 year. Motion by Doni Zeller to approve them as ready, seconded by Terry Trower. All in favor, motion carried.

Maureen Hollenbeck presented Rule Proposal #6, In the rough stock events, if not enough contestants ride the following splits shall be followed: one (1) ride - 100% of the purse; two (2) rides - purse split 60-40; three (3) rides - purse split 50-30-20; four (4) rides - purse split 40-30-20-10; five (5) rides - purse split 30-25-20-15-10; six (6) rides - purse split 29-24-19-14-9-5. This payoff counts toward year end standings. (PRCA rule). Motion by Maureen to send accept, seconded by Bogie Webb. Rule passed by membership vote.

Maureen Hollenbeck presented rule proposal #7. Discussion was held that it was too late in the new year to add this rule and therefore withdrew her rule proposal.

Rule Proposal #8 was presented by Doni Zeller and Zeller made a motion to pass the rule, seconded by Brian Runge. Proposal passed by membership vote.

Rule Proposal #9 was presented by President Hamlin. Discussion was held and motion by Kyle Hapney to table seconded by Tom Jones, motion was passed by membership to table rule proposal.

Rule Proposal #10 on Stand Alone events was presented by President Hamlin. Terry Trower made motion to amend to include that winnings will not be counted in all around and to allow the board of directors to fine tune the rule, seconded by Robert Runge. Amended rule proposal passed by membership.

Rule Proposal #11 was presented by President Hamlin. Proposal died for lack of motion to vote on proposal.

Rule proposal #12 was presented and then withdrawn by Terry Trower.

Rule proposal #13 was presented and motioned on by Donna Green. Seconded by Tom Jones. Rule proposal passed by membership vote.
