### Garbage/Recycling Pick-up

Columbia County Solid Waste is our new garbage and recycling contractor.

Garbage/Recycling pick-up is every Friday *except* when a holiday falls **on a Friday**; then it will be the Thursday before. They do have separate trucks for garbage and recycling so do not be alarmed if one gets picked up before the other. If it is not picked up on Friday please contact them or the office and we will get that taken care of for Monday.

Residents must supply their own containers and items **MUST** be placed to the curb by 6 a.m. to ensure pick-up. Garbage is limited to 6 bags per household. Recycling can be co-mingled; cardboard should be broken down and separate. Recycling should be in a clear plastic bag or bin/tote you supply.

The polls are open from 7:00 AM to 8:00 PM. If you need to vote by absentee ballot or register, you may apply at the Village Office or by visiting [myvote.wi.gov](http://myvote.wi.gov). You must have proof of residence: driver's license, utility bill, bank statement, government document etc. that has your current street address on it to register and a photo id to vote.

If your address has changed you must re-register with the correct address! Any questions please contact the office!

### License Your Pet(s)

- The limit on pets is 3 dogs or 3 cats or no more than 4 dogs and cats residing in one residence per Village Ordinance.
- If you no longer have a pet that was previously licensed please contact us so we can remove them from the pet licensing system.
- You may mail or drop off your rabies certificates with payment, please enclose a self addressed stamped envelope for return of your tags.
- Licenses **NOT** obtained by April 1, 2019, will be subject to a late fee and potential citation from the Columbia County Sheriff's Department!
- Citation for an unlicensed dog is \$218.50
- **PROOF OF RABIES VACCINATION IS REQUIRED BEFORE A LICENSE WILL BE ISSUED.**
- License Fees: Spayed/neutered dog or cat \$5.00  
Unaltered dog or cat \$10.00

Please Remember...

- ❖ Dogs must be leashed or fenced and not allowed to run free.
- ❖ Clean up after your pets when walking in the Park or on Village streets!

## **CHANDLER PARK**

Exciting things are coming to our premier park! This spring we will be installing new playground equipment. In addition, the Village received Tree grants from the WI DNR & ATC. We will be using this money to remove the infected ash trees that have been marked and replanting new trees. ## **Permits, Ordinances, Setbacks**

There have been numerous violations concerning the following Village Ordinances:

- Failure to obtain a building permit
- Violation of property lines and front and rear setbacks, zoning can be obtained at the office.
- Parking on unimproved surfaces – no parking on grass! Must be gravel or hard surface.
- Junk appliances, unlicensed and inoperable vehicles
- Fences - permit required, 2-ft off property line

The Village Ordinance Book is posted on our website. When in doubt, call the Village office. Residents are reminded that ***permits must be obtained for most property improvements.***

When planning your construction project, please allow a two-week time frame for appropriate permits, estimates, locates, etc.

## **POOL FENCE ORDINANCE 10-1-113**

Ordinance #10-1-113 has been revised as of January 2019 and a permit will be required. If you have any questions you can call the Village Office.

## **Open Burning – Village Ord. 3-2-11**

Burning trash/garbage is prohibited. Burning barrels are no longer allowed within the Village of Pardeeville. Spring burning of dry leaves and other non-offensive dry yard debris is only allowed from April 1<sup>st</sup> through May 31<sup>st</sup>. *Burning of damp yard waste and unattended burning is also prohibited and is subject to a citation/forfeiture for violations.* Outdoor cooking and campfires are allowed per Village Ordinance. See the Village Code of Ordinances or call the Village Hall if you have any questions.

## **CDBG Block Grant - Income Survey's**

The Village of Pardeeville plans to apply for a grant to help fund sanitary sewer main upgrades and street reconstruction throughout the community.

A grant can help reduce the burden of the costs at the local level for the project.

The grant application process includes an income survey of residents in the project areas. Each family in the area in which we will be conducting the improvements is asked to complete a survey. The information gathered from the survey will help determine if the Village will apply for grant funds. The Village is required to obtain completed surveys from a high percentage of families, so your participation is very important.

You will soon receive the survey in the mail. Please complete your survey and mail it to the Village in the envelope provided by February 25, 2019. Our new bills are out. Please be sure to contact the office if your phone number has changed or you have disconnected your land line!

Utility bills are mailed on the last day of the month and due the 20<sup>th</sup> (or next business day if a weekend.) If payments are not received on the due date; late notices are automatically generated to include with the next bill.

If you do not receive your bill, please call the office and we can get you a total. Failure to pay by the due date will result in a penalty and past due notice being generated.

If you are moving in, please contact the office to get a service application. If you are moving out contact the utility department to schedule a final reading and bill sent to your new address.
