New Business:

- a. The Council discussed the best approach for Norman's request to raise chickens in Lambs Grove. They discussed conducting a pilot program granting permission to the Norman's to have chickens for a defined period of time following certain guidelines. The Norman's would be required to obtain permission from adjoining neighbors. The discussion was tabled until next month giving time for council members to research the issue further and for the Norman's to obtain written permission from their adjoining neighbors.

- c. Humke moved and was seconded by DeGoey to set the date for the public hearing on ordinances 2016-002 and 2016-003 for November 3, 2016 at 7:00 p.m.

Staff and commissions reports

Mayor: Edwards will be attending the Emergency Management meeting on Wednesday, October 12th. Edwards reported that he had received two citizen concerns. One was regarding a wall that was in place along the creek to control the flow of water that is crumbling. Edwards will contact her to discuss that the issue is a homeowner's and not the city's. The other concern was in regards to a) curb repair b) repair of the light on the city's sign on F-48 and c) the delay in the sewer work on Walnut. Thomassen will contact the resident to report that the curb project has been put on hold due to other repairs that have been a higher priority and that Clark is working on getting the light repaired. Edwards will contact him regarding the sewer project. The leak was repaired on September 21st.

Streets: Thomassen reported that the Thomas Jefferson project has been completed.

Sewers: DeGoey reported that Klocke had contacted two potential contractors to fix the remaining sewer line. DeGoey will contact JP Drain Cleaning & Plumbing to assess lining the pipe.

Parks: Humke reported that the park is still being mowed.

Tree Steward: Fouts will obtain a quote from a tree service on how much it would cost to take down two separate dead limbs of property owners who have been given notice to take them down but have not. The fee would then be assessed to the homeowners. Both limbs are hanging over the street.
