President's Report

I will start this month's report with words from the Letter Carrier Guide. This booklet provided by the NALC to new members during orientation and includes a section entitled:

A Contract That Protects You

The NALC is the exclusive nationwide bargaining representative for all city letter carriers. That means NALC negotiates one collective-bargaining agreement for all city carriers employed by the Postal Service.

This "National Agreement" is the "law of the workplace." It spells out the terms of employment and therefore affects nearly every facet of a letter carrier's job. Members should read the Agreement and keep a copy for reference.

NALC's elected National Officers have negotiated new contracts every two to five years in face-to-face meetings with Postal Service officials since 1971. Every negotiated contract must be approved by majority of the membership. In this way, every NALC member can have a voice in decisions vital to his or her job. If we are unable to agree with the Postal Service on a negotiated contract, the NALC can go to arbitration to attain a new National Agreement. While the National Agreement establishes uniform wages and working conditions for letter carriers throughout the United States, Article 30 of the contract permits individual branches to bargain over a number of workplace issues. This allows local leaders to negotiate certain aspects of local work schedules, such as vacation bidding, job postings and overtime lists.

A Grievance Procedure That Safeguards Your Rights One of the most significant gains NALC members have achieved is a comprehensive grievance procedure. The grievance procedure allows letter carriers to challenge postal management conduct that violates the National Agreement. NALC officers throughout the union—stewards, branch officers, regional officers and the national leadership are all involved in the grievance process, enforcing your rights in the job. By providing members with skilled representation in dealing with management, the NALC works to ensure fair and decent treatment for all letter carriers.

The National Agreement, like all important documents is only effective when it is adhered too. When an employee is not treated fairly and in accordance with the National Agreement then the Contract makes a good coaster at best. It takes the entire membership to enforce the contract. From the City Carrier Assistants with the lowest relative standing to the most senior FTR Carrier in

the office when one is harmed we all are. When a member observes the abuse of an employee without objecting, the Contract suffers. Far too many times I hear "I don't want to make waves because I fear my hours will be cut or my working conditions and treatment will change" or for fear of retaliation from the Supervisor, employees will not write a statement to defend the contract or each other. If I can set some minds at ease, carriers do not like to see other carriers mistreated. Many will not tolerate it and will object to protect the rights of another carrier if given a chance. **Continued on page 2**

NEXT BRANCH MEETING: THURSDAY, FEBRUARY 12, 2015 AT THE LETTER CARRIER HALL

If you notice an incomplete schedule, one that forces an employee to call for his/her schedule **object to it**. Tell a Steward, Call the hall. If unreasonable expectations are made for a Carrier on either side of you, object. If you notice training isn't sufficient to give a junior employee a fair shot, step in and help, offer advice or assistance. Do not let the contract be ignored, do not let it weaken.

This "National Agreement" is the "Law of the Workplace." It spells out the terms of employment and therefore affects nearly every facet of a letter carrier's job. The job is defined, the work methods are agreed to. When Management attempts to change those agreements its for no other reason because they didn't read or understand the document when they were craft employees themselves, or they have come from another craft and have not carried mail or understand the job at all. Take the advice of the Letter Carrier Guide and read the National Agreement. Ask questions when they arise and challenge authority when the contract is violated.

SECTION 2. Shop Stewards

Nomination and election of Shop Stewards will be held at each Post Office, section or station during the last week in January. A notice will be sent to the present Stewards, announcing said election, by the Branch Secretary at least one week in advance. The number of Shop Stewards will be in accordance with the National Working Agreement. The Branch Secretary will be notified of the results of the election by February 1.

Organizing the Branch: When I meet with new Employees during the Carrier Academy, I get a chance to talk about the NALC what we are, Our History and thoughts about the future of the NALC. I started out being reluctant to share the fact that it is a choice to join that Nationwide 92% of all City Letter Carrier "Choose" to join the NALC. As the number of new employees grow I have seen the right to choose as a powerful organizing tool. Many new employees welcome the chance to be an NALC member.

As of December 1, 2014 we have 596 Active FTR Members carrying and carrying 39 scabs a ratio of 93.35% and 1.35% above the Nation. City Carrier Assistants, The Branch has 183 on the rolls with only 8 scabs or 99.56%. The NALC boasts a rate of organized at 92% Nationwide for Active Members and a CCA rate of 83%. **Overall Branch 1477 is 94% organized.**

Although you may bid from the opt being assigned a position does not mandate your leaving the opt.

Causality is the relation between an event and a second event where the second event is understood as a physical consequence of the first. We should all ask our supervisors what's the standard operational procedure (SOP) in our office with dog incidents. If they say "yes", ask for it to be posted in a location that everyone may have the opportunity to see it. "I don't know" or "I think so" is not a viable answer and should be immediately addressed.

Deferred Annuities

Deferred annuities are when a carrier (or other Postal Employee) leaves the USPS before being eligible for regular retirement, with plans to take their retirement at a later date when they become eligible. Should the carrier die while in this "waiting" period, their surviving spouse would have no entitlement to any annuity, since none had been earned. The carrier's estate would only be entitled to any funds contributed to the retirement plan prior to having left the service. Also, health benefit entitlements are lost under a CSRS-deferred annuity and are suspended with FERS-deferred retirement.

This same loss of entitlement can occur when a person is on worker's compensation (OWCP) and is subsequently

separated from the USPS. While they continue to draw their entitlement from the Dept. of Labor, they are not an employee. If they should die from a condition other than their job-related injury/illness, their spouse would lose that income. A person who is on OWCP and has been separated from the rolls of the Postal Service needs to file for disability retirement within one year of the separation. If they are eligible for regular retirement at the time of the separation, they also need to apply. They can elect to remain on compensation, but it would guarantee their surviving spouse an annuity should death occur outside the compensatory condition.

Legislative Update

With the mid-term elections done, the first order of business for lawmakers was voting on committee leadership posts for the 114th Congress. With regard to committees of importance to the NALC, Rep. Darrell Issa (R-CA) will no longer chair the oversight and Government Reform Committee. In a contested race, Rep. Jason Chaffetz (R-UT) won as chairman and Rep. Elijah Cummings (D-MD) will continue to serve as the ranking member on the committee.

of the elections shifted power in favor of the GOP in the House and Senate starting in January, there has been much discussion about whether funding will be extended for a short-term, allowing the 114th Congress to set its priorities. Alternatively, the current Congress could provide funding through the end of the fiscal year.

The four postal unions have been lobbying to secure moratorium language in whatever funding mechanism moves at the end of the year to prevent the closure and consolidation of 82 mail processing plants in 37 states.

Subcommittee on Federal Workforce and Postal Service will be led by current chairman Rep. Blake Farenthold (R-TX) and Rep. Stephen Lynch (D-MA) is expected to remain as ranking member. The House Appropriations Committee, Rep. Hal Rodgers (R-KY) will remain chairman and Rep. Nita Lowey (D-NY) will remain as ranking member.

In the Senate, when Republicans take over control in January, it is expected that Sen. Ron Johnson (R-WI) will take the lead of the Homeland Security and Government Affairs Committee (HSGAC). During the 113th Congress, he spearheaded a failed amendment to S. 1486 that would have put the Postal Service into bankruptcy and destroy all postal collective-bargaining agreements. The current committee chairman Sen. Tom Carper (D-DE) will become the ranking member.

Congress returned after the Thanksgiving recessed for the lame-duck session to tackle outstanding legislative business, primarily funding the government beyond Dec.12 when the current continuing resolution (CR) the funds the government now is set to expire. Over the last several weeks, House and Senate appropriators and leaders have been discussing the details and the duration of such a funding measure. Given that the outcome

For some lawmakers, the solution to the manufacture financial crisis caused by the pre-funding mandate remains eliminating six-day and door delivery and implementing another round of closures and consolidations.

So we are making one last push to build support for our long-standing initiatives before Congress adjourns in December. Currently, we have 67 co-sponsors of our door delivery resolution (H. Res. 711) Just as we have done in the past on the six-day resolution (H. Res. 30), we are looking for a strong finish with this Congress on this resolution. We need all of our friends on this resolution so that we can send a message to the next Congress that door delivery cuts are off limits. Everyone should contact their Senator and Congressman and ask them to co-sponsor both resolutions if they haven't already done so.

The USPS Board of Governors has announced that Postmaster General and Chief Executive Officer Patrick R. Donahoe has decided to retire February 1, 2015 after 39 years with the Postal Service. He will be replaced by Megan Brennan, who currently is the Postal Services chief operating officer.

Working to elect members of Congress who support NALC priorities is the primary objective of our political affairs operation. There has never been a more important time to participate in the NALC's political process. Our political action fund helps pro-labor, pro-letter carriers candidates get elected so they can go to Washington to support and protect letter carrier jobs. The NALC is not partisan and neither is our fight. Our struggle is for letter carrier jobs and we deserve support for that struggle from both sides of the aisle.

We encourage all NALC members to know and understand the process and how to get involved.

What is a PAC?

A Political Action Committee (PAC) raises money for the purpose of defeating or electing candidates to

elected office.

- PACs are formed by corporations, associations, labor unions and individuals with common interests.
- PACs solicit voluntary contributions from individuals with common interests to advance a political process
- PACs are nonpartisan entities whose primary concern is to elect qualified candidates regardless of party affiliation.

Why Should I Join the NALC's PAC?

- Our PAC identifies and contributes to candidates who support issues important to letter carriers.
- Joining the PAC provides letter carriers with the opportunity to build electoral and legislative power required to ensure decisions that impact their lives are made with their best interests in mind.
- Only NALC members can contribute to the PAC.
- Union dues are not used for political contributions.
- PAC contributions are voluntary and can stop at any time. There is no open season.
- We encourage PAC members to make suggestions for political contributions and to attend local fundraisers.
- PAC members are encouraged to attend local events for members locally who support letter carrier legislative priorities.

What to do when you are injured on the job

Part I

A traumatic injury is defined as:

"A wound or other condition of the body caused by external force, including stress or strain, which is identifiable as to the time and place of occurrence and member or function of the body affected. The injury must be caused by a specific event or incident or series of events or incidents within a *single work day or work shift*." The key to this definition is that an event or events must have occurred during a *single workday or work shift*.

Step 1: Notifying your Supervisor

Immediately notify your supervisor and request:

Form CA-1, Federal Employee's Notice of Traumatic Injury and Claim for Continuation of Pay/Compensation (must be supplied immediately)

Form CA-16, Authorization for Examination and/or Treatment (must be supplied by your manager with 4 hours)

Form CA-17, Duty Status Report (must be supplied immediately)

Forms CA-1 and CA-17 are available at the Department of Labor website: <http://www.dol.gov/owcp/dfec/regs/compliance/forms.htm>

Step 2: The CA-1

If you do not need immediate medical attention, fill out the CA-1. The burden of proof in every OWCP case rests on the injured worker; you must be an active participant in the claims process. Be thorough in describing the accident and related factors.

Fill out the CA-1 yourself – do not let a supervisor fill it out for you! At the bottom of the CA-1, question number 15 allows you to choose either Continuation of Pay (COP) or Sick leave. If you elect COP you will be paid your regular pay for 45 calendar days.

For the first three days of COP, you must use either sick leave, annual leave or leave without pay. After that, you will continue to get paid every two weeks as if you were working. If your absence exceeds 14

days, ask the Postal Service to convert your 3 days to COP and credit the proper leave account. You must supply medical evidence of your injury, signed by a doctor within 10 days to qualify for COP.

Once you have reviewed and signed your CA-1, physically hand the completed CA-1 to your supervisor. Do not leave it on your supervisor's desk or inbox. Request that your supervisor gives you the signed receipt (page 4) immediately. Once you are certain that the CA-1 has been properly completed, request a copy for your file.

The CA-1 receipt establishes a record of your injury and the date you filed your claim.

The Postal Service has 10 working days to submit the CA-1 to the Office of Worker's Compensation Programs, (OWCP). Once management has completed their portion of the CA-1, get a copy of it for your files. Build a file of every document related to your injury, including medical reports and documents from the Postal Service and OWCP.

Step 3: Seeking Medical Treatment

Form CA-16 authorizes payment for medical treatment and provides an initial medical report. Make sure the Postal Service properly fills out their portion of the CA-16, signing and dating it and putting **OWCP's** address in Box 12. The CA-16 is a payment voucher for medical treatment for on the job injuries. You can use the CA-16 to see the doctor of your choice.

You have the right to seek treatment from your own doctor. If the Postal Service insists that you go to their doctor, you have to be seen by them but **you do not have to be treated by them**. If you are examined by a physician's assistant or nurse practitioner, your medical report must be counter-signed by a doctor.

Provide the doctor with a copy of the CA-17. The Postal Service is responsible for filling out the job requirements on the left (side A) of the CA-17. Your doctor fills out the right (side B) of the CA-17, listing any medical restrictions. Make a copy of the completed CA-17 and give one copy to your supervisor.

The Postal Service has 10 business days to send your claim to OWCP. OWCP will send you a notification including your claim number. If you do not receive a notice from OWCP with your claim number contact your shop steward or National Business Agent's office.

Your medical records are protected by the Privacy Act. Your Postmaster, manager and supervisor are

not entitled to your personal medical records. OWCP is responsible for the protection of all of your medical records.


