# ANDOVER GLEN HOMEOWNER ASSOCIATION FORUM – none UNFINISHED BUSINESS

- Norm received signed notarized insurance form for our irrigation contractor to sign and notarize and return.
- Follow-up Xcel reimbursement process continues: Irrigation damage claims for the Xcel work along Parker Road. The claims are for \$191.25 and \$198.00, for a total of \$389.25. We already paid our contractor, Centennial Sprinkler; reimbursement will be made directly to Andover Glen Homeowners. Will follow up with Norm and review invoices and possible additional damage discovery upon activation of sprinkler system.
- Discussion on installing solar lights for added security in the park areas, much cheaper than electrical installation; 1 installed thus far and is doing well; 3 other may be placed on corners of the courts, discussion continues
- Republic Waste Service 3 year contract is expiring in July.
  - 1. Receipt of 6 bids (2 from Garbage Man)
  - 2. Spread sheet of pricing and benefits attached (roll offs, etc) provided for board review
  - Republic selected on overall benefits, price & present established customer service
     5 year contract agreed upon by the board
