

**2020 BLEI HBCU COLLEGE TOUR
ACT PREPARATION BOOTCAMP**

The Beta Lambda Educational Foundation, a Missouri non-profit corporation (“BLEI”) conducts an annual HBCU College Tour for high school students in the Greater Kansas City Metropolitan Area. The purpose of the BLEI HBCU College Tour is to increase the opportunity for participating students to earn admittance into college and to increase student awards of scholarships and other forms of financial aid.

BLEI recognizes the importance of student success on college admittance exams, specifically the ACT exam. As a result, the BLEI is excited to offer support to participants of the 2020 HBCU College Tour (“Participants”) through a 5-week ACT Test Preparation Bootcamp.

Space is limited! Only twenty (20) students will be selected to participate in the ACT Test Preparation Bootcamp.

Eligible Participants:

- Students who have registered to participate in the 2020 BLEI HBCU College Tour.
- Students who have registered to take the December 14, 2019 ACT Exam.
- Preference will be given to Seniors and Juniors (but Freshman and Sophomores may apply)

Cost: \$100 Participant Fee.

100% of this \$100 fee will be refunded to students once they have completed the ACT Preparation Bootcamp Classes AND submitted a copy of their December 14, 2019 ACT Exam results to BLEI.

Classes. BLEI will offer ACT preparatory classes on each of the dates referenced above provided by a certified ACT trainer in preparation for the ACT Test scheduled for Saturday, December 14, 2019 (the “Classes”).

Deposit. In order to participate in the Classes, each Participant must pay BLEI a deposit in the amount of \$100 on or before the first day Classes are scheduled to begin (“Deposit”). The Deposit will be returned to Participant when:

- Participant successfully completes all of the Classes; and
- Participant delivers a copy of Participant’s ACT Test Score results from the December 14, 2019 ACT Test to BLEI.

Participant Obligations. It is the intent of BLEI to offer the Classes to Participant at no cost to Participant; however, BLEI will bear all costs associated with the engagement of the instructor, the instruction manual and course materials for the Classes and snacks to be made available to Participant during each Class. As a result, BLEI expects the following from each Participant:

- Participant must be signed up to take the ACT Test on December 14, 2019 and may be asked to show proof of being signed up for the test;
- Participant will bring the following materials to each class:
 - one spiral notebook/composition book dedicated solely to the Classes
 - two sharpened # 2 pencils
 - one folder dedicated solely to the Classes for course materials and study guides
 - the course instruction book [2019-2020 ACT Prep Guide] which will be provided by BLEI and given to Participant at the first Class;
- Participant will perform all the assignments assigned during the Classes;
- Participant will be attentive throughout the duration of each Class;
- Participant will not use or display a cell phone during any Class session (cell phones must remain put away throughout the duration of each Class);
- Participant will not sleep or put his/her head down during Class instruction;
- Participant will not engage in any disruptive behavior during the Classes; and

- Participant WILL deliver a copy of Participant’s test results for the December 14, 2019 ACT test.

If Participant fails to meet the above obligations or is asked to leave any Class prior to the end of the Class session, Participant may be removed from the program and excused from Class participation and will not be eligible to receive a refund of the Deposit.

Reimbursement. Upon Participant’s successful completion of ALL of the obligations provided above, BLEI will reimburse Participant the full amount of the Deposit.

Each of the parties agrees to be bound by the above terms and conditions.
