**Booths:** Booth spaces are 12' x 12'. No displays should exceed the boundaries. Exhibitors requiring additional room may rent an additional space. Advance reservations and payment are recommended for displays requiring two adjacent spaces or electricity. Tents or canopies are welcome. Vendors are expected to provide their own tables, chairs, and props. All booth spaces are on the street surface. No grass or turf is available. All booth spaces are numbered on the street. Vendors may begin setting up at 4:30 p.m. Friday, May 29th. Exhibits must remain in place until 9 p.m. Sunday, May 31st. Vehicles may be parked in local parking lots or on numerous side streets. Food booth spaces are 24' x 10'.

Electrical outlets are limited. If electricity or double space is required advance registration is strongly recommended. No running water connections are available. We do not have an ice vendor or provider.

**Unless an application is rejected, no refunds shall be made. All activities and events will take place, rain or shine.**

Exhibitors are expected to collect tax for all sales and are responsible for filing their own returns.

All vendors offering rides or physically interactive attractions must be properly inspected and licensed by the state of Georgia. Proof of licensing and insurance must be provided with registration.
