- 1. Call to Order: Supervisor Judy Maike called the meeting to order at 1:10 pm

- **C. Township Bills** Amount: \$16,491.89 (cks 12289 12317 & E638 E643).). Motion by Trustee Chaffee with support by Trustee Long to approve the payments. Ayes all. So moved.
- **D. Budget Review**: Reports distributed and reviewed. November is 67% of FY 22/23.
