#### How You Are Tracked on the Web

Is it me or paranoia? Seems that each time I do a search and go to another web page my previous search shows up as an ad on the new web page.

This morning, if you opened vour browser and went to NYTimes.com, an amazing thing happened in the milliseconds between your click and when the latest news appeared on your screen. Data from this single visit was sent to 10 different companies, including Microsoft and Google subsidiaries, a gaggle of traffic-logging sites, and other, smaller ad firms. Nearly instantaneously, these companies can log your visit, place ads tailored for your eyes specifically, and add to the ever-growing online file about you.

There's nothing necessarily sinister about this subterranean data exchange: this is, after all, the advertising ecosystem that supports free online content. All the data lets advertisers tune their ads, and the rest of the information logging lets them measure how well things are actually working. And I do not mean to pick on *The New York Times*.

While visiting the Huffington Post or *The Atlantic* or Business Insider, the same process happens to a greater or lesser degree. Every move you make on the Internet is worth some tiny amount to someone, and a panoply of companies want to make sure that no step along your internet journey goes unmonitored.

Even if you're generally familiar with the idea of data collection for targeted advertising, the number and variety of these data collectors will probably astonish you.

While the big names - Google, Microsoft, Facebook, Yahoo, etc. - show up in this catalog, the bulk of it is composed of smaller data and advertising businesses that form a shadow web of companies that want to help show you advertising that you're more likely to click on and products that you're more likely to purchase.

To be clear, these companies gather data without attaching it to your name; they use that data to show you ads you're statistically more likely to click. That's the game, and there is substantial money in it.

As users, we move through our internet experiences unaware of the churning subterranean machines powering our web pages with their cookies and pixels trackers, their tracking code and databases. We shop for wedding caterers and suddenly see ring ads appear on random web pages we're visiting. We sometimes think the ads following us around are "creepy." We sometimes feel watched. Does it matter? We don't really know what to think.

Already, the web sites you visit

reshape themselves before you like a carnivorous school of fish, and this is only the beginning. Right now, a huge chunk of what you've ever looked at on the internet is sitting in databases all across the world. We read about how Google bypassed Safari's privacy settings, whatever those were.

Or we read the details about how Facebook tracks you with those friendly like buttons. Behind the details, however, are a tangle of philosophical issues that are at the heart of the struggle between privacy advocates and online advertising companies: What is anonymity? What is identity? How similar are humans and machines? This article is an attempt to think through those questions.

There are software programs to block tracking while browsing the internet. I wonder what they do with their tracking history?

I hope to accomplish that you know you are smarter than your computer, that the computer is a tool, and you are the master of that tool. If you have any questions you would like answered in this column please send them to mouse@pc-s4u.com

The daycare provides fulltime caregivers with short-term relief by providing time to grocery shop, attend support groups or visit friends and family.


All participants must be preregistered. The program is not designed to provide medical or counseling services, but to provide support for caregivers and their loved ones.



## View From the Other Side

In his book, The Great Spiritual Migration, Brian McLaren levels some stinging accusations at Christianity and the institutional church. "For centuries, Christianity has been presented as a system of beliefs," McLaren writes. "That system of beliefs has supported a range of unintended consequences, from colonialism to environmental destruction, subordination of women stigmatization of LGBT people, from anti-Semitism to Islamophobia, from clergy pedophilia to white privilege."

McLaren continues, centuries, Christians have presented God as a supreme being who showers blessings upon insiders who share certain beliefs proper and institutional affiliation but who punishes outsiders with eternal torment." McLaren asks, "What would it mean for Christians to recover their faith, not as a problematic system of beliefs, but as a just and generous way of life, rooted in contemplation and expressed in compassion?"

McLaren's critique of institutional Christianity lit off a barrage of thought in me: What would happen if we who call ourselves Christian stopped reciting the creeds and started living the creeds? What would happen if we gave up sanctimoniously singing timeworn hymns like 'Amazing and began practicing gracefulness in our relationships? Who would we become if we stopped worshipping Jesus and began following Jesus and living like Jesus? (It's worth noting that Jesus never asked us to worship him; he asked us to follow him. We worship because worshipping requires less of us than

following.)

A few years ago I decided to read the Gospels with a focus solely on Jesus - how Jesus lived, what Jesus said and taught. I suspended all preconceived beliefs, all the dogma the church drilled into my head over the decades. My one goal was to discover who the historical Jesus was with the hope of living more like him.

What I discovered was a man who lived lovingly and compassionately; who forgave his enemies, including those who crucified him; who valued societal outcasts; and who eschewed power and status.

I discovered that Jesus never set out to start a church or establish a new religion, but who understood religion as a transformative experience rather than an escape plan from this world. I discovered a Jesus who lived by values that ran contrary to the cultural values of wealth, power, and status. I discovered that the only people Jesus had problems with were the institutionally religious.

So the next time we find ourselves in church mindlessly reciting those high-sounding creeds, we should ask ourselves if we're actually *following* Jesus or just *worshipping* Jesus.

Are we following a Jesus who welcomed outsiders, practiced forgiveness and offered compassion to the broken; or are we worshipping a Jesus who merely founded an institution and created a body of dogma?

Most of all, we should ask ourselves if our worship has softened our hatred of those who see and do things differently from us?

McLaren summarizes it best: "Love was Jesus' prime directive - love for God, for self, for neighbor, for stranger, for alien, for outsider, for outcast and even for enemy. Love meant that neither beliefs or words, taboos nor systems, structures nor the labels that enshrine them mattered. Love took priority over everything."

## **Explaining Changes for 2018 Tax Returns**

As you may have heard, the IRS began processing 2018 tax returns on Jan. 28. And so it begins!

There are some major changes that affect both individual taxpayers and businesses. For many of you, 2018 tax preparation will be more, not less, complicated. For others, who always had a simple tax form using the standard deduction, it will still be simple, maybe...

Many of the changes for personal income tax are temporary, meaning they will expire at the end of 2025. Honestly, I would not worry about that. Who knows who will be president and what party will control what part of Congress and whether any of these will survive beyond 2020?

The list is lengthy, but here are just some of the big changes:

- The Standard Deduction: It will be \$24,000 for those Married Filing Jointly (MFJ), \$18,000 for Heads of Household (HOH) and \$12,000 for Single or those Married Filing Separately (MFS). Seniors (age 65) will get an extra \$1,300 or \$1,600 tacked on to the deduction amounts, depending on your filing status
- **Personal Exemption:** There are no personal exemptions to reduce your taxable income.
- **Dependent Tax Credit:** The Child Tax Credit will increase to \$2,000 per child under age 17 and \$1,400 of it will be refundable,

meaning that you will get up to this amount as a refund even if you do not owe or pay any tax. There is also a new Other Dependent Credit of \$500. The maximum income for phase out of these credits is \$400,000 for MFJ and \$200,000 for any other filing status.

- **Alimony**: This was a deduction for those paying it, and income for those receiving it, but alimony will no longer be counted for either in 2018 for any settlements after 2017.
- Moving Expenses: This deduction has been eliminated for all but active military personnel.
- Casualty and Theft Losses: These will no longer be deductible unless in the case of a federally declared disaster.
- Medical Expenses for Everyone: The threshold of 10% of Adjusted Gross Income (AGI) to claim medical expenses has been reduced to 7.5% by the new tax law for 2017 & 2018, but will go back up to 10% in 2019.
- Real Estate, State Income and Sales Tax: The deduction for all three combined will be capped at \$10,000. You still have the choice of either state income or sales tax as a deduction, but the cap applies. This represents a tax hike for those folks who have high property or state income taxes more than the new standard deductions.
  - Home Mortgage Interest:

New acquisition debt is limited to \$750,000 but debt incurred before 12/15/17 is grandfathered at \$1,000,000. Home equity loans not specifically related to the purchase, construction or substantial improvement of a qualified home is **no longer** deductible.

- **Employee** and **Miscellaneous Deductions Subject** to 2% AGI: These have all been suspended until 2026. This means unreimbursed employee that expenses (job search expenses, union dues, small tools, protective clothing, etc.) and other expenses like tax preparation fees, investment/ advisory fees, IRA custodial expenses, safe deposit boxes are not deductible. However, they may still be deductible as your state's itemized deductions.
- Mileage Rates for Deductions: Use of your vehicle for business increases to 54.5 cents per mile, for charitable work stays at 14 cents, and for medical expenses in traveling for medical treatment or to pick up prescriptions increases to 18 cents
- Tax Brackets: There are seven tax brackets, and most are lower: percentages are 10, 12, 22, 24, 32, 35 and 37 percent.
- Alternative Minimum Tax (AMT): The AMT exemption increases to \$70,300 for Single and HOH taxpayers, \$109,400 for MFJ and Qualifying Widower (QW), and

\$54,700 for MFS. The phase-out levels begin at \$500,000 for Single, HOH & MFS and \$1,000,000 for MFJ. The Excess Taxable Income Threshold for the 28% Rate is \$191,100 for Single and MFJ and \$95,550 for MFS.

- Shared Responsibility for Health Insurance: The penalty for not having health insurance is still in effect for 2018; it remains at \$695 per month per uninsured adult and \$347.50 per month for each child, limited to 2.5% of household income related to a threshold amount for the taxpayer's filing status, with a maximum of \$2,085 per family. The penalty will not be in effect for 2019.
- Federal Estate Tax: For those few of us worrying about estate tax, the exemption amount per person is 11.11 million, and will be indexed for inflation until 2026. There is still the provision that a surviving spouse may carry over the remaining portion of the exemption of the deceased spouse.

So there you have it – just some the major tax changes for individuals in 2018. Check the IRS website at www.irs.gov and IRS publications as reliable sources of tax information.


