**Resolution 2014-08**

Authorizing Creation of Paid Positions of Fire Fighter and Administrator

**WHEREAS**, there exists a need within Fire District #1 in the Township of Jackson, County of Ocean, to create paid positions entitled "Firefighter" and "Administrator" to perform those duties as necessary; and

**WHEREAS**, the Commissioners of Fire District #1 in the Township of Jackson, County of Ocean have determined that they are desirous of creating said positions.

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners of Fire District #1 in the Township of Jackson, County of Ocean, as follows:

1. The positions of Firefighter and Administrator are hereby established.
2. The annual salary, benefits and terms and conditions of employment for these positions shall be as determined by the Commissioners and as otherwise mandated by New Jersey statutory law.
3. The Firefighter and Administrator shall undertake any and all responsibilities and administrative obligations relative to the fire district as required and as directed by the Commissioners.
4. The Firefighter and Administrator shall be under the supervision of the Commissioner as designated by the Commissioners pursuant to N.J.S.A. 40A:14-81.3.
5. This resolution shall take effect following final adoption and publication pursuant to New Jersey statutory law.

NOTICE is hereby given that the above resolution was introduced and passed upon first reading at a regular meeting of the Commissioners held on January 13, 2014 and will be considered for final passage at a meeting to be held February 10, 2014 at 8:00 PM at the Whitesville Volunteer Fire Company firehouse, 81 South Hope Chapel Road Jackson, New Jersey 08527 at which time and place any person wishing to be heard shall be given the opportunity.

PLEASE TAKE FURTHER NOTICE that copies of said resolution shall be made available to each person requesting a copy of same during the week prior to the second reading of this resolution and during the hearing concerning the same, and said copies may be obtained from the Commissioners.



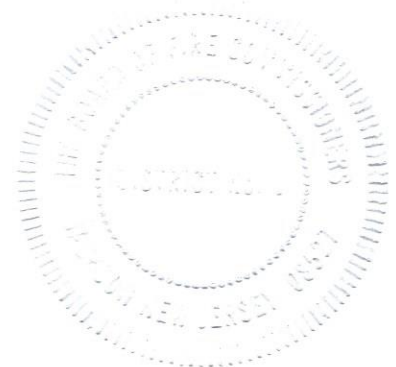
