# **Special Notice**

The state of Illinois requires all participants of a Hunting Test and Field Trial to carry a valid hunting license and habitat stamp. This included gunners, handlers and scouts. The law does not apply to non-residents who wish to participate in these events. The sponsoring club will obtain a waiver of license for non-resident participants.

### **Eligibility and Risk**

Open to all pointing breeds in good standing with the AKC. AKC registered dogs must be 6 months of age or older on the event date. ILP/PAL dogs are eligible to participate. Bitches in season are <u>not</u> allowed and are <u>not</u> allowed on the grounds. Dogs are ineligible to enter a test if the test's Judge or Judge's family member has owned, sold, leased, boarded, trained or handled the dog within one year of the test date. Owners or handlers entering a test do so at their own risk and agree to assume responsibility for any damage caused by them or their dogs.
