(2) BY AJAMIE, LLP FOR THE PERIOD  
MARCH 1, 2020 THROUGH  
APRIL 30, 2020

Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows:

1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which appointed Peter S. Davis as Receiver of DenSco Investment Corporation ("Receivership Order").

2. Pursuant to this Court's Order Re: Petition No. 1, the Court approved the Receiver's compensation at the rate of \$250.00 per hour together with all reasonable costs

1 and expenses incurred relating to these services as Receiver. These services are billed by  
2 and paid to the Receiver's firm, Simon Consulting, LLC.

3 3. Pursuant to the Order Re: Petition No. 1, the Receiver has engaged the  
4 services of the law firm of Guttilla Murphy Anderson, P.C. of Phoenix, Arizona, and the  
5 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services  
6 of the firm together with all reasonable costs and expenses incurred on behalf of the  
7 Receiver.

8 4. Pursuant to this Court's *Order Re: Petition No. 10*, the Receiver has engaged  
9 the services of the law firm of Frazer Ryan Goldberg & Arnold, LLP of Phoenix, Arizona  
10 and the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the  
11 service of the firm together with all reasonable costs and expenses incurred on behalf of the  
12 Receiver.

13 5. Pursuant to this Court's *Order Re: Petition No. 45*, the Receiver has engaged  
14 the services of the law firm of Ajamie, LLP of Phoenix, Arizona and the Receiver has  
15 agreed to pay the law firm compensation on an blended contingency basis at agreed rates for  
16 the service of the firm together with all reasonable costs and expenses incurred on behalf of  
17 the Receiver.

18 6. Pursuant to this Court's *Order Re: Petition No. 2*, the Receiver is authorized  
19 to file this fee petition without including as exhibits the itemization of services rendered to,  
20 and costs incurred or expended on behalf of, the Receivership, provided that the fee petition  
21 includes a statement that anyone desiring additional information concerning the services and

1 costs to be paid under the fee petition may obtain redacted information from the Receiver by  
2 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a  
3 written request specifying the additional information requested at least three (3) days prior  
4 to the date set for any hearing on the fee petition. The *Order Re: Petition No. 2* further  
5 provides that upon request of the Court, the Receiver shall make available for in camera  
6 review by the Court the itemized statements and supporting documentation for the services  
7 and costs to be paid under the fee petition.

8         7. The Receiver has submitted an itemized statement for services rendered to this  
9 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable  
10 costs incurred or paid during the period of April 1, 2020 through April 30, 2020. The total  
11 amount requested for payment by the Receiver is \$6,491.10. The Receiver believes that this  
12 amount is reasonable and should be paid from the Receivership Assets.

13         8. The law firm of Guttilla Murphy Anderson, P.C. has submitted an itemized  
14 statement for services rendered to this Receivership and for reimbursable costs incurred or  
15 paid during the period of April 1, 2020 through April 30, 2020. The total amount requested  
16 for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$11,428.62. The  
17 Receiver believes that this amount is reasonable and should be paid from the Receivership  
18 Assets and has therefore approved this statement for payment.

19         9. The law firm of Frazer Ryan Goldberg & Arnold, LLP has submitted an  
20 itemized statement for services rendered to this Receivership during the period April 1, 2020  
21 through April 30, 2020. The total amount requested for payment by the law firm of Frazer

1 Ryan Goldberg & Arnold, LLP is \$715.00. The Receiver believes that this amount is  
2 reasonable and should be paid from the Receivership Assets and has therefore approved this  
3 statement for payment.

4 10. The law firm of Ajamie LLP has submitted an itemized statement for services  
5 rendered to this Receivership during the period March 1, 2020 through April 30, 2020. The  
6 total amount requested for payment by the law firm of Ajamie LLP is \$2,250.00. The  
7 Receiver believes that this amount is reasonable and should be paid from the Receivership  
8 Assets and has therefore approved this statement for payment.

9 WHEREFORE, the Receiver respectfully requests that the Court enter an order  
10 authorizing the Receiver to pay from Receivership Assets:

11 1. The amount of \$6,491.10 to Simon Consulting, LLC for services rendered and  
12 costs incurred or paid during the period of April 1, 2020 through April 30, 2020;

13 2. The amount of \$11,428.62 to Guttilla Murphy Anderson, P.C. for services  
14 rendered and costs incurred or paid during the period of April 1, 2020 through  
15 April 30, 2020;

16 3. The amount of \$715.00 to Frazer Ryan Goldberg & Arnold, LLP for services  
17 rendered to the Receivership during the period from April 1, 2020 through April 30, 2020;  
18 and

19 4. The amount of \$2,250.00 to Ajamie LLP for services rendered to the  
20 Receivership during the period from March 1, 2020 through April 30, 2020.
