City Council Minutes

October 2nd, 2017

The City Council of the City of New Munich met in regular session at 6:48p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, and Ron Doll were present.

Bryan Kasten was sworn in as Council Member.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the minutes from September 5th, 2017 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of two medical calls last month.

Waste /Water Operator, Tom Valerius was present to inform the Council that Roger Boecker from R-Way Pumping did maintenance on the South lift pump. Preferred Controls replaced pressure sensors and calibrated them.

Minnesota Department of Health sampled for nitrate.

Steph Boecker was present and informed the Council that she believes the MDH came to R-Way Pumping to take samples. Her concern was that they did not present identification just said Tom said I should come test here. Tom will look into this.
Tom turned the water off at 420 Western St by request from owner. He also turned off the water to the Baseball Park and cemetery for the season.

On a motion by Ron Doll, seconded by Shawn Duevel carried and approved the water and sewer bills for the third quarter will be estimated due to new meters and software issues. Hopefully we can get this on track to do monthly readings and billings soon.

Sandy Zierden was present to submit a donation of \$240.00 to the Fire Department to help pay for installation of the internet connection.

Homeowner's rental Ordinance was tabled till next regular scheduled meeting.

On a motion by Ron Doll, seconded by Bryan Kasten carried and approved the City will install 2 new Welcome to New Munich Signs. The cost will be \$763.00 for 2 signs. The New Munich Lions will donate \$450.00 toward the signs.
