All invoices are due and payable according to the terms expressly stated by J & A Coil Sales. The failure to pay on the due date of each invoice shall deem the debt to be delinquent. In the event of a delinquency, J & A Coil Sales may impose a finance charge of 1.75% per month or the highest rate permitted by law on the delinquent amount until paid. In the event of a delinquency, all collection expenses and attorney's fees in connection with the collection of the delinquent debt shall be due and payable by the applicant. In the event any suit or action is filed to collect this account, I (we) agree that the prevailing party shall be entitled to recover a reasonable attorney's fee in the amount fixed and determined by the trial and all appellate courts and in any adversary proceedings in bankruptcy court. In the event applicant owes more than one thousand dollars (\$1,000.00) to J & A Coil Sales, applicant grants J & A Coil Sales a security interest in applicant's business personal property, including equipment, inventory and accounts receivable, and authorizes J & A Coil Sales to file an UCC-1 to perfect such security interest.
