AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA AMENDING CHAPTER 9, NUISANCES, SECTIONS 9-7 AND 9-8 OF ITS CODE OF ORDINANCE TO PROVIDE FOR THE SECURING OF CONSTRUCTION SITES AT THE TIME OF HURRICANE EVENTS AND TO PROVIDE REGULATIONS FOR THE CONTROL OF EROSION, FUGITIVE DUST AND STORMWATER PROTECTION DURING LAND DISTURBING ACTIVITIES; BY AMENDING CHAPTER 18, UTILITIES, ARTICLE III. STORMWATER CONTROL, SECTIONS 18-41, 18-44 AND 18-45 IN ORDER TO CLARIFY THE PURPOSE AND INTENT OF SAID ARTICLE, TO AMEND THE NOTIFICATION PROCEDURES IN THE EVENT OF A SPILL OR DUMPING INCIDENT AND TO AMEND THE ENFORCEMENT ACTIONS AVAILABLE TO THE TOWN IN THE EVENT OF A VIOLATION OF THE ARTICLE; BY AMENDING CHAPTER 19 VEGETATION, ARTICLE II. FERTILIZER, SECTIONS 19-22, 19-25 AND 19-29 TO PROVIDE THAT STORMWATER INLETS OR STRUCTURES SHALL BE FERTILIZER FREE ZONES, TO MODIFY THE REGULATIONS PERTAINING TO GRASS

CLIPPINGS AND VEGETATIVE MATTER AND TO AMEND THE ENFORCEMENT ACTIONS AND PROCEDURES AVAILABLE FOR ARTICLE II; PROVIDING AUTHORITY TO CODIFY; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
