Motion to amend Submitted by the ASDI bylaws committee

<u>Motion:</u> Amend ASDI bylaws Article V – Region Representatives and World Service Delegates, Section 6 – Responsibilities, D

<u>Current Wording:</u> Attend all Intergroup meetings.

<u>Suggested Wording:</u> Attend all Intergroup meetings unless prior notification has been given to a board member.

Rationale: Current wording does not allow for any absence regardless of circumstances. This places an undue burden on the Rep/Delegates. This change permits absence provided there is prior notification.


