## AGREEMENT FOR TEMPORARY CONSTRUCTION WATER USE

- Contractor is required to sign up for temporary use of water for housing construction purposes at the Oquirrh Mountain Water Company Office before using any water within OMWC boundaries. Contractor shall pay a **refundable deposit of \$1,000.00** at the time of sign up for approximately four months of water use (120 Days). An **inspection fee of \$55.00** will be collected to check for violations, such as a meter setter "jumper", improper backflow protection, cross connections, and for a final check of the meter setter and meter box for any damage done to it during its use. If any violations and/or damage are done to the meter setter or meter box, the contractor will be denied the use of the water and any amount needed for repairs shall be deducted from the deposit. In the event, there are no violations or damages done to the meter setter or meter box and if a refund is due after deducting the inspection fee, the remainder of the \$1,000.00 deposit shall be refunded to the Contractor. Applicable deposit refunds will be nailed out within approximately two weeks after agreement is settled.
- A **\$50.00 deposit** will be charged for a water bib adapter with a 3/4" connection and is refundable after inspection of the bib adapter for any damages.
- Contractor shall only use the water designated in this agreement. The use of a different meter setter location or hose bib adapter is a violation of this agreement and is subject to a fine.
- If any damage has occurred to the meter setter or meter box before or at the time of the final check, the contractor shall be held responsible for repairs. Repairs may be done by a contractor and shall be inspected by OMWC, or repairs may be done by OMWC and contractor shall be billed for parts and labor.

5. If an extension of this agreement is needed prior to the Ending Date, the contractor shall return the agreement to the OMWC Office and additional inspection fees will be added to the amount that will be deducted from the deposit.

6. **The applicant MUST notify Oquirrh Mountain Water Company within 7 business days before selling/ closing of said property.** Contractor must contact the Company at (801) 508-0397 or E-mail: [nthomas@omwc.us](mailto:nthomas@omwc.us) to insure connection fees are collected, customer applications are completed and the OMWC water share is transferred to the new owner. Failure to do so shall result in forfeiture of the entire deposit.

# Notice to Temporary Construction Water Use Permit Holders

You and your company are required to protect the public drinking water system from contamination and/or pollution while using a lot meter setter assembly.

Contaminants and pollutants can flow back into the public drinking water system (Backflow) as a result of connecting a hose directly, or indirectly, from a hose bib connection to anything that could contain, or has contained, non potable water, liquids, or gasses. Such a connection is termed a Cross-Connection and is strictly prohibited. As you may be able to imagine, this kind of connection could cause serious health problems, or death!

All hoses and appurtenances connected to the Temporary Water Use meter setter bib must be protected by an approved Air Gap, or Backflow assembly/device. The assembly/device shall be approved for the existing degree of hazard in accordance with the Utah Division of Drinking Water Backflow Prevention and Cross-Connection Control rules and regulations.

Placing the discharge end of a hose attached to a Temporary Water Use meter setter bib directly into a gutter, storm drain, ditch, sanitary sewer system, water tank, storage vessel, swimming pool, etc., is strictly prohibited! Connecting to any auxiliary water sources is also strictly prohibited! Hoses shall not discharge directly onto the ground, nor be connected to any equipment containing chemicals or other substances without approved Backflow Protection installed. Hoses shall be disconnected from the meter setter, and protected against possible contaminants and pollutants while not in use.

Periodic onsite inspections will be made at the designated Temporary Water Use meter setter use location. Backflow Prevention and/or Cross-Connection Control violations will result in immediate Temporary Construction Water Use Permit revocation and may result in fines.

It is very important that any person(s) using Temporary Water Use hose connection understand the possible hazards and liabilities of Backflow and/or a Cross-Connection. Remember, you can affect the quality of the water you drink. Should you have any questions regarding this, or other Quality Control matters, please contact Keith Fryer at (801) 250-0453.
