### **Running Order and Class Information**

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at [LKSAGE@aol.com](mailto:LKSAGE@aol.com) or by phone (503) 840-4303 (cell), email preferred.

**SITE INFO:** This trial will be held in two rings indoors on packed dirt. Crating is on concrete around the periphery of the rings. **You may set up your crating space Thursday afternoon beginning at 1 pm.**

**On Thursday, June 20th, there will be a College Graduation Rehearsal at the Amphitheater. We have STRICT rules that we MUST follow on that day. Below are the instructions given to us directly from the fairgrounds:**

#### **Thursday, June 20<sup>th</sup>: Clark College Graduation Rehearsal**

**Load-in Hours, including RV arrivals must end by 5:00pm.**

Purple Gate will be locked at 5:00pm and exit will only be allowed through the Loading Dock Gate.

**No arrivals and no entry of RVs between 5:00pm – 11:00pm. No exceptions.**

**Any RV trying to arrive between 5:00pm – 11:00pm will be denied entrance for the entire show.**

**No arrivals and no re-entry between 5:00pm – 11:00pm on Thursday, June 20th. No exceptions. Violations of these rules will not be tolerated and could result in a bench hearing.**

#### **DIRECTIONS TO THE TRIAL SITE:**

*From I-5:* Take EXIT 9 (in Washington), head West on 179<sup>th</sup> Ave. for ½ mile, turn left onto 2<sup>nd</sup> Ave., then turn left again at Gate 7. Exposition and Equestrian Bldg. is on the right, at the end of the road. Feel free to park in any marked parking spot around the arena building. Please do not block any arena entrance or access road.

**MEASURING:** We will have a VMO on site so all dogs without height cards will have to be measured, including the 24 & 24C” dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day near the trial secretary’s table. It is your responsibility to have your dog measured BEFORE you run.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

**VOLUNTEERS:** We will be using the white board for sign-ups. If you can, please volunteer for the class(es) that you can help with. CRAC will issue raffle tickets to each worker to be used in a DAILY workers raffle which will have many wonderful items and services. The workers raffle will be drawn each day in the early afternoon. There will be a special raffle draw which will occur daily for those volunteering as chute setters or leash runners. Prizes must be claimed by the conclusion of the trial on Sunday.

**FAST CLASS WALK THRU All FAST Classes will walk together. ONE walk thru for all FAST Classes. Then we will Run all FAST Classes together by jump height.**

**Walk through groups may be changed at the trial to accommodate for conflicts and workers.**

**CONFLICTS:** We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a “C” instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

**MOVE-UPS:** The deadline for move-ups is Monday, June 17, 2019 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

**FOOD: Sweet AI's** will be the food vendor on site and will be open from 9:00 am to the end of the trial each day.
