- 4.8.4. July 8th, 2016 tickets for the Dodger Game. Members will have to RSVP number of tickets they plan on purchasing before the chapter buys the tickets.
- 4.8.5. Options for seating at Dodger game-left pavilion, top deck, infield reserve, and preferred seating.
 - 4.8.5.1. #1 Doria Padilla (CLU)- Left Pavilion includes all you can eat with the cost of the tickets, \$40 a ticket
 - 4.8.5.2. #42 Dalia Hernandez (CSUSB) will be participating in the Dodgers game and to justify the expense we are reaching out to the baseball team on campus to have a presentation regarding the sport or career.

4.9. Student Leadership Conference- Dalia Hernandez

- 4.9.1. 8 person committee was great, THANK YOU! Thank you to CSUSB for allowing to host.
- 4.9.2. 412 people attended the conference.
- 4.9.3. 4 breakout sessions with 25 different workshop sessions were offered so students could select their workshops.
- 4.9.4. Total raised minus expenses was \$6.702.46.
- 4.9.5. Most categories were rated with extreme satisfaction.
- 4.9.6. Many TRiO college students presenting and facilitating workshops.
- 4.9.7. Major concentration was fundraising for this year's SLC. There was about \$50,000 in kind contributions.
- 4.9.8. Booked facilities through Upward Bound since we are housed on that campus.

- 4.9.9. The chapter received 33 scholarship applications and 10 students were selected to receive the \$500 scholarship.
- 4.9.10. The scholarship application will continue to be online.
- 4.9.11. General recommendations: more signage throughout the conference, limit the workshops to 3 instead of 4, limit the workshop length to 50 minutes instead of an hour, increase the number of students each program can bring to the conference, create a space for chaperones while students are attending workshops.
