# A. Budget Resolutions for 2024

After reviewing the actual plus estimated column for the 2024 expenditures, Budget Resolution No. 2024-B1 was submitted by the clerk for consideration. B1 transfers \$1,000 from the General Government account to the Capital Outlay account.

<u>Knapp made a motion, seconded by Griffin, to approve Budget Resolution 2024-B1. Ayes 2, Opposed 0, Abstain 0, Absent 1. MOTION CARRIED.</u>

### B. Work on the budget for 2025 (2024 Collected 2025)

The budget details as presented by the clerk were reviewed. The total allowable levy limit this year from the State is \$69,345. There is a projected decrease of several of the expenditures due to only having two elections in 2025 and no road construction. The total projected expenditures for next year are \$342,189, the total projected revenues are \$272,844 and the total reserves are \$269,997. The clerk will post the summary by October 24<sup>th</sup> for the November 11, 2024 meeting.

# C. Resolution authorizing to levy more than the minimum set by the State (if needed)

The Board decided to work with the allowable levy limits as set by the State.
