A ribbon-cutting ceremony was held on September 15th to mark the completion of the Lake View Hospital and Clinic expansion.

According to Greg Ruberg, CEO/president of Lake View, the construction project went remarkably well despite many challenges presented by the intervening pandemic. The construction that connected the hospital and clinic finished slightly under budget and very closely to the projected timeline.

“Our guiding principles were integration and collaboration, and now our primary care staff are right across from where specialists are working. We've created a space for a true team environment where they can work together as one campus, and made a significant investment into the wellness of Lake County,” said Ruberg.

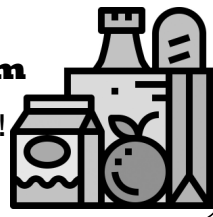
