**AN ORDINANCE TO AMEND CHAPTER 184 “VEHICLES AND TRAFFIC”,
SECTION 184-13 “PARKING TIME LIMITED ON CERTAIN STREETS AND
AND MUNICIPAL PARKING LOTS” OF THE CODE OF THE TOWNSHIP OF
BLAIRSTOWN**

WHEREAS, the Township Code contains a section regarding locations throughout the Township where parking is prohibited at certain times; and

WHEREAS, upon the input of the Chief of Police, the Township Committee has reviewed the current Code and determined that it is necessary to amend the Code section to add another location; and

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Blairstown, Warren County, New Jersey, that Section 184-13 entitled “Parking time limited on certain streets and municipal parking lots” of the Code of the Township of Blairstown be an is hereby amended as follows:

SECTION 1. Chapter 184 “Vehicles and Traffic”, Section 184-13 “Parking time limited on certain streets and municipal parking lots” shall be amended to read as follows:

B. Municipal parking lots. In accordance with the provisions of this subsection, no person shall park a vehicle for a period of more than 24 consecutive hours in any of the following described municipal parking lots.

East Avenue Community Park	24 hours	Both	East Avenue
Blairstown Township Givens-Belet Memorial Hall	24 hours	Both	Route #521
Municipal Parking Lot at the Corner of Stillwater Road and East Avenue	24 hours	Both	Stillwater Road
Vail Athletic Field	24 hours	Both	Vail Road
Walnut Valley Athletic Field	24 hours	Both	Route #94

C. Municipal parking lots. No person shall park a vehicle for longer than the time limited between the hours listed on any day (except Sundays and public holidays) in any of the following described municipal parking lots.

Location	Time Limit	Side	Name of Street
Main Street Parking Lot	No parking between 11 pm and 6 am	Both	Main Street

All other portions of this Chapter remain unchanged.

SECTION 2. All ordinances or parts of ordinances of the Township of Blairstown inconsistent herewith are repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

SECTION 4. This law shall take effect immediately upon final passage, approval and publication as required by law.

~~NOTICE IS HEREBY GIVEN, that Ordinance 2019-23, an ordinance to amend Chapter 184 "Vehicles and Traffic", Section 184-13 "Parking Time Limited on Certain Streets and Municipal Parking Lots" of the code of the Township of Blirstown, was introduced at the August 14, 2019 Regular Township Committee Meeting. The ordinance restricts the amount of time motorists can park at the Township's Main street Parking lot.
